This is a Purchase Order Contract. Only those bidders which have been prequalified as a Bidder or a PO Prime Contractor may bid on this contract. The Contractor MUST have the NCDOT Work Codes 006000 (Disaster Debris Removal) and 006010 (Cut and Shove) to be considered for award. Failure to do so shall cause the bid to be deemed irregular and will not be processed.

The North Carolina Department of Transportation is requesting bids for the: **CUT AND SHOVE CREW FOR REMOVAL OF STORM RELATED DEBRIS FROM STATE MAINTAINED ROADWAYS IN DUPLIN COUNTY.** All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.

The availability date for this project is January 18, 2016. The completion date is December 31, 2016.

Sealed bids must be received in the Division 3 Engineer's Office at 5501 Barbados Blvd., Castle Hayne, North Carolina 28429 by 2:00 PM on Thursday, December 17, 2015. Entire bid package must be submitted by the contractor at the Bid Letting or the bid will be deemed irregular and rejected. Bids must be submitted on the official bid sheet included in the proposal



and display the following statement on the front of the envelope:
