Failure to do so shall cause the bid to be deemed irregular and will not be processed.***

The North Carolina Department of Transportation is requesting bids for the: **CUT AND SHOVE CREW FOR REMOVAL OF STORM RELATED DEBRIS FROM STATE MAINTAINED ROADWAYS in ONSLOW COUNTY.** All quantities are estimates only. The Contractor is to furnish labor, material, equipment, and traffic control.
