NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

Project Description: DD00196

The North Carolina Department of Transportation is requesting bids for **GRADING**, **DRAINAGE**, **PAVING AND STRUCTURE** work located on **SITE 1 - REPLACEMENT OF BRIDGE 56 OVER GREAT SWAMP ON SR 1342 (MEMORIAL CHURCH RD) and SITE 2 - REPLACEMENT OF BRIDGE 301 OVER BUCK MARSH SWAMP ON SR 1753 (CARMACK RD)** in **Wayne County**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor <u>prior to submitting your bid</u>. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified <u>prior to beginning work on the project</u>. Sealed Bids must be received in the Division Office at 509 Ward Blvd., Wilson, NC 27893 by 2:00 PM on Tuesday, January 10, 2017. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:



Do NOT submit bids for projects let by Division 4 to the NCDOT Statewide Project Letting Office.
