Measurement and Payment

Coir Fiber Wattle Barrier will be measured and paid as the actual number of linear feet of coir fiber wattle barrier installed and accepted. Such price and payment will be full compensation for all work covered by this provision, including, but not limited to, furnishing all materials, labor, equipment and incidentals necessary to install the coir fiber wattle barrier.

<u>PROJECT SPECIAL PROVISIONS</u> <u>ALUMINUM BOX CULVERT/ALUMINUM PIPE</u>

Perform the required box culvert/aluminum pipe construction in accordance with this Special Provision.

The work covered by this special provision consists of furnishing all labor, equipment, materials and a manufacturer representative on site, to install the aluminum box culvert/aluminum pipe as indicated on the plans and Standard Specifications.

Design of the aluminum box culvert/aluminum pipe shall be the responsibility of the Contractor and shall comply with the latest AASHTO design specifications and requirements. The Contractor shall submit, fourteen (14) days prior to commencing work at each site, two sets of detailed plans and design calculations that have been checked and sealed by a North Carolina Registered Professional Engineer. The plans should be submitted to the Resident Engineer.
