Subject: Invitation to Bid on Division Contract

The North Carolina Department of Transportation is requesting bids for **ON CALL POLYUREA, COLD APPLIED PLASTIC, PAINT AND RUMBLE STRIP INSTALLATION** located at **VARIOUS LOCATIONS WITHIN DIVISION 4** in **EDGEcombe, HALIFAX, NORTHAMPTON, NASH, JOHNSTON, WAYNE AND WILSON COUNTIES.**


It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for these projects. Bids submitted without posted addendums will be rejected.
