The North Carolina Department of Transportation is requesting bids for **GRADING, DRAINAGE, PAVING, CULVERT & STRUCTURE** work located at **BRIDGE NO. 64 OVER TOWN CREEK** in **EDGECOMBE COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. 
