NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

Project Description: DD00259

The North Carolina Department of Transportation is requesting bids for **GRADING, DRAINAGE, PAVING and STRUCTURE** work located on **BRIDGE NO. 83 on SR 1600 OVER QUANKEY CREEK AND BRIDGE NO. 185 on SR 1616 OVER MARSH SWAMP** in **HALIFAX COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Bids must be submitted using the Expedite 5.11a-1 software through Bid Express®. You will only have one method of submission. Bids must be submitted by 2:00 PM on Tuesday, June 26, 2018.
