The North Carolina Department of Transportation is requesting bids for **DD00395 – ALL WAY STOP INSTALLATIONS** at **VARIOUS LOCATIONS** in **EDGEcombe, HALIFAX, NASH AND WILSON COUNTIES**.

SBE PROGRAM INFORMATION

This is a SBE contract and to qualify for the NCDOT SBE Program a firm must have an annual gross income of \$1,500,000 or less, exclusive of materials. **Only contractors currently certified as a SBE Contractor by the Contractual Services Unit of NCDOT and listed in the Directory of Transportation Firms at bid opening will be eligible to bid on this project.** Prospective bidders who qualify for the SBE Program and are not currently certified should submit a completed application packet prior to bid submittal to allow for review time.
