The North Carolina Department of Transportation is requesting bids for **MISCELLANEOUS CONCRETE CONSTRUCTION** for **ADA CURB RAMPS** located in **HALIFAX AND TARBORO** in **HALIFAX AND EDGEcombe COUNTIES**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. 
