PRE-BID MEETING

A mandatory pre-bid meeting is scheduled for Thursday, August 15, 2019 at 1:30 PM in the Division Four Conference Room located at 509 Ward Boulevard in Wilson. Bids received from companies which are absent from the pre-bid meeting will not be considered.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. 
