NOTICE TO PROSPECTIVE BIDDERS

Subject: Invitation to Bid on Division Contract

Project Description: DD00231

The North Carolina Department of Transportation is requesting bids for **GRADING**, **DRAINAGE AND PAVING** work located on **SR 1629** (**JULIAN ALLSBROOK HWY.**) **FROM VIRGINIA AVE. TO SOUTH ST.** in **Halifax County**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. Firms that wish to bid on these projects as the prime contractor must be prequalified as a Bidder or PO Prime Contractor prior to submitting your bid. Firms that wish to perform as a subcontractor to the prime contractor must be prequalified prior to beginning work on the project. Sealed Bids must be received in the Division Office at 509 Ward Blvd., Wilson, NC 27893 by **2:00 PM** on **Tuesday, October 10, 2017**. Bids must be submitted on the official bid sheet included in the proposal and display the following statement on the front of the envelope:

The North Carolina Department of Transportation, in accordance with the provisions of Title VI of the Civil Rights of 1964 (78 Stat.252) and the Regulations of the Department of Transportation (49 C.F.R., Part 21), issued pursuant to such act, hereby notifies all bidders that it will affirmatively insure that the contract entered into pursuant to this notice will be awarded to the lowest responsible bidder without discrimination on the grounds of sex, race, color, or national origin.

It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for these projects. Bids submitted without posted addendums will be rejected.

Electronic bidding is acceptable.

As of June 28, 2016 Division 4 can accept electronic bids through Bid Express®.

Electronic Bid Preparation with Manual Delivery is also acceptable. If you wish to submit your bid in this manner, please download the EBS file and the NC_DBE file. Please submit a CD or USB flash drive of your electronic bid along with a printed, signed copy of your bid attached to the proposal.

Do NOT submit bids for projects let by Division 4 to the NCDOT Statewide Project Letting Office.

ATTENTION DIVISION BIDDERS:

Effective with lettings on or after January 1, 2018, the NC Department of Transportation will require electronic bidding through Bid Express® on Division let construction projects. SBE contracts are excluded. As NCDOT transitions to electronic bidding, please note the following dates:

Effective August 1, 2017:

Lettings on or after August 1, 2017: all bidding will use the Expedite 5.11a-1 software. You will have two methods to submit a bid:

- 1) Printed signed proposal with a priced bid form printed from Expedite and submitted to the Division with a CD/flash drive containing the priced EBS file.
- 2) Bid submitted through Bid Express® using Expedite. You will need a NCDOT Divisions Digital ID to bid. Information regarding obtaining a NCDOT Divisions Digital ID may be found at https://connect.ncdot.gov/letting/Pages/Division.aspx.

Effective January 1, 2018:

Lettings on or after January 1, 2018: all bidding will use the Expedite 5.11a-1 software and submission will be through Bid Express[®]. You will only have one method to submit a bid:

1) Bid submitted through Bid Express® using Expedite. You will need a Digital ID to bid.
