The North Carolina Department of Transportation is requesting bids for **THIN LIFT ASPHALT PAVEMENT PRESERVATION** work located on **VARIOUS SECONDARY ROUTES** in **WILSON COUNTY**.

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform.
