The North Carolina Department of Transportation is requesting bids for **BRIDGE DECK AND JOINT REPAIR** located at **VARIOUS LOCATIONS WITHIN DIVISION 4** in **EDGECOMBE, HALIFAX, JOHNSTON, NASH, WAYNE AND WILSON COUNTIES.**

Any firm that wishes to perform work on Division Purchase Order Contracts as either the prime contractor or as a subcontractor on the project must be prequalified for the type of work they wish to perform. 
***It is the bidder's responsibility to check the previously noted website for any and all addendums that may be posted for these projects. Bids submitted without posted addendums will be rejected.***
