MEMORANDUM TO PROSPECTIVE BIDDERS

This addendum is being issued to change the contract time for this project, add Intermediate Contract Time Number 2, edit quantities for Line #0009, Thermoplastic Pavement Marking Lines (24", 120 mils) and Line # 0013, Removal of Pavement Marking Lines (24") and to distribute pavement marking plans.

The Contract Time and Liquidated Damages provision found on page 7 of the proposal should be revised as follows:

The date of availability for this contract is April 1, 2015.

The completion date for this contract is **November 20, 2015**.

The following Intermediate Contract Time Number 2 provision should be inserted into page 9 of the proposal as follows:

<u>INTERMEDIATE CONTRACT TIME NUMBER 2 AND LIQUIDATED DAMAGES:</u> (6-18-13) 108

The Contractor shall complete all the work required at SR 2053 (Jones Dairy Rd) and SR 2054 (Chalks Rd) as shown on the plans.

The date of availability for this intermediate contract time is April 1, 2015.

The completion date for this intermediate contract time is **July 31, 2015**.

The liquidated damages are **Five Hundred Dollars** (\$ 500.00) per calendar day.

Plan sheets showing pavement marking and signing for the intersections are being transmitted with this addendum. Quantities for these items were included in the original proposal with the exception of minor changes needed for Line #0009, Thermoplastic Pavement Marking Lines (24", 120 mils) and Line # 0013, Removal of Pavement Marking Lines (24").

Attached please find the attached revised bid sheets, with the correct quantities for bidding purposes. Please substitute the new bid sheets for the bid sheets in the original proposal and acknowledge receipt of this addendum in the proposal.
