PRE-BID CONFERENCE

A mandatory Pre-Bid Conference will be held at 2:00 p.m. on Tuesday, March 15, 2016 at the Division Five Office, 2612 N. Duke Street, Durham N.C. 27704. We will discuss the scope of the project and give bidders the opportunity to ask any questions they may have. Attendance at the Pre-Bid Conference is required in order for your bid to be considered.

Any changes made to the contract during the pre-bid conference will be documented and included in an addendum, which will be mailed or Faxed to all meeting attendees.

SBE PROGRAM INFORMATION

This is a SBE contract and to qualify for the NCDOT SBE Program a firm must have an annual gross income of \$1,500,000 or less, exclusive of materials. **Only contractors currently certified as a SBE Contractor by the Contractual Services Unit of NCDOT and listed in the Directory of Transportation Firms at bid opening will be eligible to bid on this project.**

Prospective bidders who qualify for the SBE Program and are not currently certified should submit a completed application packet prior to bid submittal to allow for review time. The application packet and additional information on the program may be obtained online at:
