**Prequalifying to Bid:** All prospective bidders shall be prequalified as a Bidder or PO Prime Contractor with the Department of Transportation prior to submitting a bid, in conformance with provision **SP01 G01**. All required prequalification statements and documents shall be filed with the Contractual Services Management Section at least four weeks prior to the date of opening bids.
