The published volume entitled *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2012* with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in this contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

If the proposal is accepted and the award is made, the contract is valid only when signed either by the Contract Officer or such other person as may be designated by the Secretary to sign for the Department of Transportation. The conditions and provisions herein cannot be changed except over the signature of the said Contract Officer or Division Engineer.

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

1. Download the entire proposal from the Connect NCDOT website, bind and return the entire proposal with your bid.
2. The Bidder shall submit a unit price for every item. **\*\*\*Unit Prices shall be rounded off by the bidder to contain no more than TWO decimal places.\*\*\***
3. An amount bid shall be entered for every item.
4. Changes to any entry shall be made by marking through the entry in ink and making the correct entry adjacent thereto in ink. A representative of the Bidder shall initial the change in ink. **Do not use correction fluid, correction tape or similar product to make corrections.**
5. The bid shall be properly executed on the included **Execution of Bid – Non-collusion Affidavit, Debarment Certification and Gift Ban Certification** form. All bids shall show the following information:

The contractor and/or subcontractor(s) shall be prequalified in the work code(s) for they will complete. Any contractor identified as working outside their expertise will be considered in default of contract.

### **GENERAL**

This contract is for Vegetation Management Services along interstate, primary and secondary roads in Western Guilford County. Work consists of trimming grass, pruning, chipping and removal of woody vegetation along roadsides and adjacent to guardrail and other highway appurtenances as directed by the Engineer.

All materials and workmanship shall be in accordance with the following:

The Project Special Provisions, Project Standard Provisions, most current Standard Special Provisions, *Manual of Uniform Traffic Control Devices (MUTCD)*, Provisions contained in the applicable Sections of the North Carolina Department of Transportation's *Standard Specifications for Roads and Structures* and Drawings contained in the applicable sections of the North Carolina Department of Transportation's *Roadway Standard Drawings* shall apply.

The published volume entitled *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures*, with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in the contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

**The Contractor shall begin work within seven (7) calendar days of notification. All steel and iron products that are permanently incorporated into this project shall be produced in the United States except minimal amounts of foreign steel and iron products may be used provided the combined material cost of the items involved does not exceed 0.1% of the total amount bid for the entire project or \$2,500, whichever is greater. If invoices showing the cost of the material are not provided, the amount of the bid item involving the foreign material will be used for calculations. This minimal amount of foreign produced steel and iron products permitted for use is not applicable to high strength fasteners. Domestically produced high strength fasteners are required.

Revise the *2012 Standard Specifications* as follows:

Replace all references to “State Highway Administrator” with “Chief Engineer”.

**PROJECT SPECIAL PROVISIONS****VEGETATION MANAGEMENT**

The Contractor shall perform string trimming (weedeating) around or under fixed objects, including but not limited to guardrail, signs, bridges, barriers and slopes on all interstate, primary and secondary roads as directed by Engineer. In addition, the Contractor shall be required to cut and chip trees and woody vegetation on highway right of way as directed by Engineer.

Vegetation shall be removed up to and around guardrail, to the toe of existing slope and other areas as directed by the Engineer.

Operators shall wear an approved ANSI compliant Class III safety vest while working within the state highway right of way.

The intent of this contract is for the Contractor to perform three 3 cycles of string trimming on interstate, primary and secondary roads, however, the Engineer may reduce the number of cycles

**OPERATOR WITH STRING TRIMMER**

Upon request of the Engineer, the contractor shall provide a minimum of 5 (Five) qualified operators with string trimmers. The operators must be skilled in the operation of the string trimmer and shall follow OSHA guidelines. Operators shall wear vision and hearing protection and clothing to provide sufficient protection from flying chips etc... Operators shall wear an ANSI compliant Class III safety vest, closed-to shoes, shirts with sleeves and long pants while performing the work covered by this contract.

String trimmers shall be commercial grade, gasoline powered units with a minimum cut diameter of 17". All original equipment safety devices shall be in place. The engineer may reject any equipment that is not operating in a satisfactory manner.

If needed, the Contractor shall be required to supply a trimmer with a brush attachment and/or a chainsaw for vegetation management on slopes.

**OPERATOR WITH CHAINSAW:**

Upon request of the Engineer, the contractor shall provide qualified operators with chainsaws. The operators must be skilled in the operation of the chainsaw and must follow OSHA guidelines. Operators must wear vision and hearing protection, chaps and clothing to provide sufficient protection from flying wood chips etc. Operators must wear an approved orange safety vest and must wear work shoes and shirts with sleeves while working within the state highway right of way.

Chainsaws shall be commercial grade, gasoline powered units with a minimum bar length of 18". All original equipment safety devices shall be in place. The Engineer may reject any equipment that is not operating in a satisfactory manner.

**CHIPPER CREW:**

Upon request of the Engineer, the contractor shall provide the following equipment and labor to perform chipping of woody vegetation:

- 1 Chipper w/min.12" Diameter Capacity
- 1 Tow Vehicle w/min 6 Cubic Yard Capacity
- 1 Chipper Operator
- 3 Ground Laborers

Vehicle and chipper operators shall possess the appropriate licenses and skills for the equipment used. Equipment shall be in good working order and all safety devices shall be in place. Workers shall wear vision and hearing protection, and shall not wear any loose clothing or jewelry.

Wood chips shall become the property of the contractor. Upon approval by the Engineer, chips may be dispersed within the highway right of way. Chips shall be placed so as not to interfere with drainage structures, sight distances, or turf growth.

The contractor will be required to supplement power tools with hand tools when needed to successfully complete a required vegetation management task. Hand tools will be considered incidental in nature and no additional compensation shall be made.

Any damage to adjacent and/or personal property including windshields, fences, signs, pavement and or alleged thrown rocks due to Contractor's negligence shall be replaced or repaired by the Contractor to the satisfaction of the engineer.

**METHOD OF MEASUREMENT AND BASIS OF PAYMENT:**

Measurement will be made per linear foot of properly trimmed shoulder. Trimming around and under signs will be measured according to the following chart:

<b>Sign Type</b>	<b>Sign Size</b>	<b>Trim area</b>	<b>Equivalent measurement</b>
Single Post Sign	2' X 2'	4 sqft =	4 lft
Double Post Sign (Small)	2' X 4'	8 sqft =	8 lft
Double Post Sign (Big)	2' X 8'	16 sqft =	16 lft
Triple Post Sign	2' X 12'	24 sqft =	24 lft

Slopes will also be measured by square feet and entered as linear feet.

No separate measurement will be made for trimming under single u-channel post signs or single trees as such trimming will be considered part of the per linear foot payment.

The Contractor or his representative must sign daily log sheets prepared in duplicate by the Engineer (listing the dates, hours, descriptions, and locations of all work performed) before payment can be made. Travel time shall not be paid.

All work or items necessary to complete the work other than those listed on the "Bid Proposal Form" will be considered incidental in nature and no additional compensation shall be made.

Herbicide application shall be conducted by individuals who possess the appropriate applicator's license from the NC Department of Agriculture or individuals under their direction and understands, and follows the herbicide labeling before applying the product.

The Contractor shall maintain traffic during operations and provide, install, and maintain all traffic control devices in accordance with these project guidelines, the Project Special Provisions, North Carolina Department of Transportation *Standard Specifications for Roads and Structures*, and the current edition of the *Manual of Uniform Traffic Control Devices* (MUTCD).

The Contractor shall utilize complete and proper traffic controls and traffic control devices during all operations. All traffic control and traffic control devices required for any operation shall be functional and in place prior to the commencement of that operation. Signs for temporary operations shall be removed during periods of inactivity. **DEBARMENT CERTIFICATION**

Conditions for certification:

1. The prequalified bidder shall provide immediate written notice to the Department if at any time the bidder learns that his certification was erroneous when he submitted his debarment certification or explanation filed with the Department, or has become erroneous because of changed circumstances.
2. The terms *covered transaction*, *debarred*, *suspended*, *ineligible*, *lower tier covered transaction*, *participant*, *person*, *primary covered transaction*, *principal*, *proposal*, and *voluntarily excluded*, as used in this provision, have the meanings set out in the Definitions and Coverage sections of the rules implementing Executive Order 12549.
