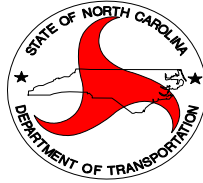

The Bidder has carefully examined the location of the proposed work to be known as Contract No. **D7POC220**; has carefully examined the plans and specifications, which are acknowledged to be part of the proposal, the special provisions, the proposal, the form of contract; and thoroughly understands the stipulations, requirements and provisions. The undersigned Bidder further agrees to provide all necessary machinery, tools, labor, and other means of construction; and to do all the work and to furnish all materials, except as otherwise noted, necessary to perform and complete the said contract in accordance with *the 2018 Standard Specifications for Roads and Structures* by the dates(s) specified in the Project Special Provisions and in accordance with the requirements of the Engineer, and at the unit or lump sum prices, as the case may be, for the various items given on the sheets contained herein.

The Bidder shall provide and furnish all the materials, machinery, implements, appliances and tools, and perform the work and required labor to construct and complete State Highway Contract No. **D7POC220** in **Orange County**, for the unit or lump sum prices, as the case may be, bid by the Bidder in his bid and according to the proposal, plans, and specifications prepared by said Department, which proposal, plans, and specifications show the details covering this project, and hereby become a part of this contract.

The published volume entitled *North Carolina Department of Transportation, Raleigh, Standard Specifications for Roads and Structures, January 2018* with all amendments and supplements thereto, is by reference incorporated into and made a part of this contract; that, except as herein modified, all the construction and work included in this contract is to be done in accordance with the specifications contained in said volume, and amendments and supplements thereto, under the direction of the Engineer.

If the proposal is accepted and the award is made, the contract is valid only when signed either by the Contract Officer or such other person as may be designated by the Secretary to sign for the Department of Transportation. The conditions and provisions herein cannot be changed except over the signature of the said Contract Officer or Division Engineer.

The quantities shown in the itemized proposal for the project are considered to be approximate only and are given as the basis for comparison of bids. The Department of Transportation may increase or decrease the quantity of any item or portion of the work as may be deemed necessary or expedient.

An increase or decrease in the quantity of an item will not be regarded as sufficient ground for an increase or decrease in the unit prices, nor in the time allowed for the completion of the work, except as provided for the contract.

INSTRUCTIONS TO BIDDERS

**PLEASE READ ALL INSTRUCTIONS CAREFULLY
BEFORE PREPARING AND SUBMITTING YOUR BID.**

All bids shall be prepared and submitted in accordance with the following requirements. Failure to comply with any requirement may cause the bid to be considered irregular and may be grounds for rejection of the bid.

1. Download the entire proposal from the Connect NCDOT website and return the entire proposal with your bid.
2. All entries on the itemized proposal sheet (bid form) shall be written in ink or typed.
3. The Bidder shall submit a unit price for every item on the itemized proposal sheet. The unit prices for the various contract items shall be written in figures. Unit prices shall be rounded off by the Bidder to contain no more than TWO decimal places.
4. An amount bid shall be entered on the itemized proposal sheet for every item. The amount bid for each item shall be determined by multiplying each unit bid by the quantity for that item, and shall be written in figures in the "Amount" column of the form.
5. The total amount bid shall be written in figures in the proper place on the bid form. The total amount bid shall be determined by adding the amounts bid for each item.
6. Changes to any entry shall be made by marking through the entry in ink and making the correct entry adjacent thereto in ink. A representative of the Bidder shall initial the change in ink. Do not use correction fluid, correction tape or similar product to make corrections.
7. The bid shall be properly executed on the included **Execution of Bid – Non-collusion Affidavit, Debarment Certification and Gift Ban Certification** form. All bids shall show the following information:
 - a. Name of corporation, partnership, Limited Liability Company, joint venture, individual or firm, submitting bid.
Corporations that have a corporate seal should include it on the bid.
 - b. Name of individual or representative submitting bid on behalf of the bidder and position or title held.
 - c. Name, signature, and position or title of witness.
8. The bid shall not contain any unauthorized additions, deletions, or conditional bids.
9. The Bidder shall not add any provision reserving the right to accept or reject an award, or to enter into a contract pursuant to an award.

CONTRACTOR'S INFORMATION

PROJECT SPECIAL PROVISIONS - GENERAL**GENERAL**

This contract is for Traffic Control, as needed, for maintenance operations on state maintained highways at various sites throughout Orange County. **Work may be required during daylight or night time hours.**

The Contractor may be required to perform traffic control for other units within Division 7.

All materials and workmanship shall be in accordance with, the Project Special Provisions, Project Standard Provisions, most current Standard Special Provisions, and Provisions contained in the applicable Sections of the North Carolina Department of Transportation's *Standard Specifications for Roads and Structures* dated 2018.

The Contractor shall keep himself fully informed of all Federal, State, and local laws, ordinances, and regulations, and shall comply with the provisions of Section 107 of the Standard Specifications.

Unit prices should reflect actual costs; unbalanced bids may be rejected per the *Standard Specifications for Roads and Structures* Article 102-14.

CONTRACT RENEWAL

1-29-2014

The contract shall commence on **February 26, 2018** and shall be effective for one (1) year or until the cost of the contract reaches \$500,000.00 per year. At the option of the NC Department of Transportation and upon agreement by the contractor, this contract may be extended for up to two (2) additional one (1) year extensions with a 3% increase in prices per year of extension.

WORK RESTRICTIONS AND LIQUIDATED DAMAGES

The Contractor shall complete the required work of installing, maintaining and removing the traffic control devices for lane closures and restoring traffic to the existing traffic pattern(s) as directed by the Engineer.

Notification of need for non-emergency Traffic Control will be made by the Engineer and may be made by email, telephone call, or fax. Any of the above methods shall be considered sufficient.

Liquidated damages for non-emergency work for this contract are One Hundred Dollars (\$100.00) per calendar day if the contractor has not started work within 48 hours from the time of notification.

Notification for Emergency Response will be made by telephone. The Contractor shall provide the Engineer with a telephone number where he can be reached 24 hours a day, seven days a week. The telephone call shall be sufficient notification and the emergency response time limit, 2 hours begins when the Engineer or his representative completes the call.

Liquidated damages for "Emergency Response" of One Hundred Dollars (\$100.00) per hour or portion thereof will be charged the Contractor for each hour after the allotted time if he has not arrived on site ready to install required emergency response traffic control.

PROSECUTION OF WORK

The Contractor will be required to prosecute the work included in each notification in a continuous and uninterrupted manner from the time he begins the work until completion and final acceptance of the work. The Contractor will not be permitted to suspend his operations except for reasons beyond his control or except where the Engineer has authorized a suspension of the Contractor's operations in writing.

In the event that the Contractor's operations are suspended in violation of the above provisions, the sum of **One Hundred Dollars (\$100.00)** will be charged the Contractor for each and every calendar day that such suspension takes place. The said amount is hereby agreed upon as liquidated damages due to extra engineering costs and increased public hazard resulting from a suspension of the work. Liquidated damages chargeable due to suspension of the work will be additional to any other liquidated damages that may become chargeable.

All work on consultant contracts, services contracts, and construction contracts shall be performed in the United States of America. No work shall be outsourced outside of the United States of America.

Outsourcing for the purpose of this provision is defined as the practice of subcontracting labor, work, services, staffing, or personnel to entities located outside of the United States.

The North Carolina Secretary of Transportation shall approve exceptions to this provision in writing.

PROJECT SPECIAL PROVISIONS – TRAFFIC CONTROL**WORK ZONE TRAFFIC CONTROL**

The Contractor shall install and maintain work zone traffic control as directed by the Engineer. The Contractor may be required to close one or more lanes of a multilane roadway. The Contractor shall supply **qualified** flaggers when closing one lane of a two-lane, two-way roadway, a pilot truck and pilot truck operator may also be required.

Compensation shall be made per each and shall include, but not be limited to, providing all necessary personnel, furnishing, installing, maintaining and removing Traffic Control Devices required by the *MUTCD* or *Standard Drawings* and any additional devices as required by the Engineer.

Emergency Response

Some situations may require the contractor to perform work within two (2) hours of notification. This Compensation for “Emergency Response” will be in addition to the specific “Work Zone Traffic Control” item; however the contractor must be on the jobsite and ready to work within the allotted time.

Method of Measurement and Basis of Payment

Time will begin when the Contractor begins the installation of Traffic Control Signs and will end when the last sign is removed. All equipment must be present and operable and all manpower

present before work time can begin. The Contractor will be paid only for those closures that are installed and maintained according to NC DOT’s *Roadway Standard Drawings* and the MUTCD which are in affect at the time of the lane closure. The Contractor or his representative must sign daily log sheets prepared in duplicate by the Engineer (listing the dates, hours, descriptions, and locations of all work performed) before payment can be made. For lane closures that last over twelve hours, additional hours will be measured to the nearest ¼ hour.

All work or items necessary to complete the work other than those listed on the “Contract Bid Form” will be considered incidental in nature including but not limited to flaggers, portable lighting, message boards, Truck Mounted Impact Attenuators (TMIA), and signs and no additional compensation shall be made. TMIA’s shall be required on all multilane highways. **No differentiation in compensation will be made for nighttime work versus daytime work.**

TRAFFIC CONTROL

The Contractor shall maintain traffic in accordance with Divisions 10, 11 and 12 of the *Standard Specifications*, the *MUTCD* and the latest revisions thereto and the following provisions:

The use of *Roadway Standard Drawings* Nos. 1101.02, 1101.04, 1101.11, 1110.02, 1130.01 will be required for the various lane closure situations. The Contractor shall maintain the existing traffic pattern at all times, except in the immediate work zone as determined by the Engineer.

Properly ballasted cones may be used instead of drums for lane closures during daylight hours. However, drums are required for the upstream taper portion of lane closures in all applications. The stationary work zone shall be a maximum of 3 miles in length at any given time unless otherwise directed by the Engineer.

Perform work only when weather and visibility conditions allow safe operations or as directed by the Engineer.

Operate equipment and conduct operations in the same direction as the flow of traffic. Do not cross medians with equipment, except at properly designated interchanges.

During periods of construction inactivity, return the traffic pattern to the existing alignment and remove or cover any work zone signs as directed by the Engineer.

General Statute 143C-6-11. (h) Highway Appropriation is hereby incorporated verbatim in this contract as follows:

(h) Amounts Encumbered. – Transportation project appropriations may be encumbered in the amount of allotments made to the Department of Transportation by the Director for the estimated payments for transportation project contract work to be performed in the appropriation fiscal year. The allotments shall be multiyear allotments and shall be based on estimated revenues and shall be subject to the maximum contract authority contained in *General Statute 143C-6-11(c)*. Payment for transportation project work performed pursuant to contract in any fiscal year other than the current fiscal year is subject to appropriations by the General Assembly. Transportation project contracts shall contain a schedule of estimated completion progress, and any acceleration of this progress shall be subject to the approval of the Department of Transportation provided funds are available. The State reserves the right to terminate or suspend any transportation project contract, and any transportation project contract shall be so terminated or suspended if funds will not be available for payment of the work to be performed during that fiscal year pursuant to the contract. In the event of termination of any contract, the contractor shall be given a written notice of termination at least 60 days before completion of scheduled work for which funds are available. In the event of termination, the contractor shall be paid for the work already performed in accordance with the contract specifications.

Payment will be made on any contract terminated pursuant to the special provision in accordance with Subarticle 108-13(D) of the *2018 Standard Specifications*.

This project may be within a county regulated for plant and/or pests. If the project or any part of the Contractor's operations is located within a quarantined area, thoroughly clean all equipment prior to moving out of the quarantined area. Comply with federal/state regulations by obtaining a certificate or limited permit for any regulated article moving from the quarantined area.

Originating in a Quarantined County

This determination of the intent of the application of this act to the contract on this project is the responsibility of the Contractor.

The Contractor shall have no claim against the Department of Transportation for any changes in the minimum wage laws, Federal or State. It is the responsibility of the Contractor to keep fully informed of all Federal and State Laws affecting his contract.
