Please refer to Article 107-15 of the Standard Specifications. The certificate of insurance **must be returned to this office by 12:00 Noon March 13, 2015.**

In addition, please submit written documentation of bidder commitment to use DBE subcontractors with the required "Letter of Intent to Perform as Subcontractor" for each subcontractor.
