Dear Mr. Snow:

Bids for the subject project were received on September 29, 2015 at 2:00 PM at the Town of Walkertown's Booe House. There was good interest in this project as evidenced by fourteen bidders picking up plans and the receipt of five (5) bids. The bids received ranged from \$680,051.00 to \$879,968.65. Please find enclosed a Tabulation of Bids for the subject project. We have reviewed the bids for accuracy and compliance with the bid documents. The low bidder, Country Boy Landscaping, Inc. of Harmony, NC, complied with the DBE goal of 7% and we found no irregularities with their bid. We also reviewed the 4 other bids and found mathematical errors in the bid submitted by Triangle Grading and Paving, Inc. and Little Mountain Builders. Their adjusted Bid Amounts are shown on the attached Tabulation of Bids. The mathematical errors in Little Mountain Builders bid resulted in their bid being considered non-responsive as the percentage of DBE participation fell to 6.8 % and less than the goal of 7%.

The low bid of \$680,051.00 is 27.2% more than our August 2014 estimate. Although the low bid is higher than our estimate, the bids were competitive and we believe represent the current bidding conditions in the marketplace as we have seen similar increases in costs on recently bid projects.

As established in Mr. Brett Abernathy, PE, PLS letter to you dated August 18, 2015, \$445,600.00 in federal funds are available for construction of this project and the Town has committed \$111,400.00 in matching funds. The Town would be responsible for funding an additional \$123,051.00 for the project to move forward.

Should the Town have the additional funding available to construct this project as bid, we recommend that the Town award a contract contingent to concurring approval from NCDOT to the low bidder, Country Boy Landscaping, Inc of Harmony, NC in the amount of \$680,051.00 in accordance with their bid.



- Multiplication errors found on bid item numbers 16 and 42. Total Bid Amount increased \$510.00. DBE percentage after adjustment still rounds to 8.26%.
- Multiplication errors found on bid item numbers 6, 23, 39, 40, 41, 51, 53, 57, 67, 69, 75 and 79. Addition error in summing Total Bid Amount which increased \$29,634.99
- ω As a result of Total Bid Amount increasing \$29,634.99, the actual % of DBE reduced from 7.1 % to 6.8%, thus Bid is considered Non Responsive.
