SYNOPSIS

SUB-CONSULTANTS ARE PERMITTED UNDER THIS CONTRACT. In order to meet the workload requirements of the Department, additional subs may be added during the contract.

The primary and/or sub-consultant firm(s) shall be pre-qualified to perform ALL of the work codes listed below for the NCDOT RIGHT OF WAY UNIT. Work Codes required are:

WORK CODES for each primary and/or sub-consultant firm(s) <u>SHALL</u> be listed on the respective RS-2 FORMS (see section 'SUBMISSION ORGANIZATION AND INFORMATION REQUIREMENTS').

This RFLOI is to solicit responses (LETTERS of INTEREST, or LOIs) from qualified firms to provide professional consulting services to:

Provide Right of Way Services for the Department statewide.

It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest. Some of the services being solicited may not require a license. It is the responsibility of each firm to adhere to all laws of the State of North Carolina. The **contractors**, and/or their **subcontractors**, must have the proper General Contractor's License, Asbestos Certifications, North Carolina Real Estate License, and/or to perform these duties as well as be **pre-qualified** through the NCDOT **Contractual Services Unit** or actively pursuing prequalification and **pre-certified** through the **Uniform Certification procedures**.

The firm must have the financial ability to undertake the work and assume the liability. The selected firm(s) will be required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00. The firm(s) must have an adequate accounting system to identify costs chargeable to the project.

It is the Department's intent to use selected primary and sub-consultant firm teams for all on-call Right of Way services work. Current on-call contracts may continue to be used throughout the original contract period, which will expire at the end of the original term. The Department will not exercise the option to extend current on-call contracts.

SCOPE OF WORK

The North Carolina Department of Transportation (NCDOT) is soliciting proposals for the services of a firm/team for the following contract scope of work:

SCOPE OF WORK

The North Carolina Department of Transportation (hereafter referred to as the "Department") is soliciting written proposals from qualified consultants (contractors) to establish a contract to provide Right of Way Services for the Department statewide. The Department will establish a list comprised of several qualified consultants to perform right of way acquisition, appraisal, relocation, property management, program support, project management, and program management services on an as-needed basis statewide. The consultant will be required to perform Right of Way Services based on an assigned task authorization, for the completion of the task or project in accordance with G.S. 136-28.1 of the General Statutes of North Carolina, as amended, and in accordance with the requirements set forth in the Uniform Appraisal Standards and General Legal Principles for Highway Right of Way, the North Carolina Department of Transportation's Right of Way Manual, the North Carolina Department of

Transportation's Rules and Regulations for the Use of Right of Way Consultants, the Code of Federal Regulations, and Chapter 133 of the General Statutes of North Carolina from Section 133-5 through 133-18, hereby incorporated by reference, including the Uniform Relocation Assistance and Real Property Acquisition Policies Act of 1970, as amended.

00168 – Project Management:

The work includes performing Right of Way tasks associated with the management/delivery of acquisition and/or relocation on an assigned project.

00170 – Property Management:

The work includes performing property management services for the clean-up, maintenance and repair of properties owned by North Carolina Department of Transportation; the collection of, all, rents on the properties; the eviction of any tenant who is in arrears with rent payments or any other legally justified reason; advertising for prospective tenants; landscape maintenance including but not limited to mowing, hedge/bush trimming, tree trimming, and removal of debris.

The Contractor must have an active Corporate NC Real Estate Broker License to be considered for Property Management assignments.

Asbestos Survey, Asbestos Abatement, Lead Paint Testing, Lead Paint Abatement, Mold Testing, Mold Remediation, and Building Removal/Demolition (see each work code below):

- 00339 Lead Paint Testing
- 00340 Lead Paint Abatement

The work includes performing clearing of buildings and improvements acquired by the Department, as assigned; performing asbestos surveys, lab analysis, asbestos abatement, as assigned; lead paint testing, lab analysis, lead paint abatement, as assigned; and hazardous mold inspection, lab analysis, mold abatement, as assigned; the hauling and removal of debris, as assigned.

The contractors, and their subcontractors, must have the proper General Contractor's License and Asbestos Certifications to perform these duties

00185 – Relocation Review:

The Department will handle all reviews pertaining to Relocation matters through the Department's normal review procedures.

00186 – Relocation Assistance:

The work includes performing all necessary services pertaining to Relocation Assistance and services required for the completion of each project in accordance with Chapter 133 of the General Statutes of North Carolina from Section 133-5 through 133-I8, and in accordance with the requirements set forth in the Department's Right of Way Manual and the Code of Federal Regulations Title 49 Part 24.

00192 – Right of Way Appraisals:

The work includes making detailed inspections of assigned properties; conforming to recognized appraisal principles and practices of the appraisal profession in estimating the value of the properties; preparing, furnishing, and delivering appraisals on all assigned properties in accordance with the requirements set forth in the Department's Right of Way Manual and the Code of Federal Regulations Title 49 Part 24.

The Contractor must be, at a minimum, a NC General Certified Real Estate Appraiser. Must be on NCDOT Approved Appraiser List.

00193 – Right of Way Appraisal Reviews:

The work includes reviewing appraisals of each parcel to be acquired for right of way purposes for conformance with USPAP and Chapter 5 of the NCDOT Right of Way Manual to determine if the appraisal is credible and its value conclusions are reasonable; making inspections of assigned properties; ensuring that all appraisals received conform to recognized appraisal principles and practices of the appraisal profession; preparing, furnishing, and delivering appraisal reviews on all assigned properties in accordance with the requirements set forth in the Department's Right of Way Manual, USPAP (Uniform Standards of Professional Appraisal Practice) and the Code of Federal Regulations Title 49 Part 24.

The Contractor must be, at a minimum, a NC General Certified Real Estate Appraiser. Must be on NCDOT Approved Appraiser List.

00194 – Right of Way Negotiators:

The work includes requesting or providing appraisals containing the necessary and required information regarding the property and the effects of the acquisition on the property; requesting or providing Preliminary Certificates of Title regarding the property and its ownership; contacting property owners to explain project impacts and the acquisition process; performing negotiations for the acquisition of real property in accordance with the requirements set forth in the Department's Right of Way Manual and the Code of Federal Regulations Title 49 Part 24; submitting final reports and the required documentation, on each property claim; preparing and providing all documentation necessary for the closing of all settled claims.

The Contractor must have an active Corporate NC Real Estate Broker License to be

considered for Acquisition assignments. All right of way agents assigned to negotiate parcels must have an active NC Real Estate Broker License.

The consultant shall perform the services as set forth herein and as described within the specific task authorization and furnish and deliver to the Department appropriate reports and other documents relative to the completion of the task.

EXCEPT AS NOTED BELOW, CONTRACTORS MUST BE PREQUALIFIED BY NORTH CAROLINA DEPARTMENT OF TRANSPORTATION CONTRACTUAL SERVICES UNIT PRIOR TO SUBMITTING LETTERS OF INTEREST.

Firms may be actively pursuing pregualification for the listed work codes; however, no work for a specific discipline will be given until the prime or sub is pregualified.

PROPOSED CONTRACT TIME: TWO (2) YEARS, WITH AN OPTIONAL ONE (1) YEAR EXTENSION.

PROPOSED CONTRACT PAYMENT TYPE: LUMP SUM and/or COST-PLUS.

SUBMITTAL REQUIREMENTS

All LOIs are limited to **FIFTEEN PAGES in WORDS (exclusive of resumes)** (**15**) pages (RS2 forms are not included in the page count) inclusive of the cover sheet, and shall be typed on 81/2" x 11" sheets, single-spaced, one-sided.

LOIs containing more than FIFTEEN PAGES in WORDS (exclusive of resumes) (15) pages will not be considered.

WORK CODES for each primary and/or sub-consultant firm(s) <u>SHALL</u> be listed on the respective RS-2 FORMS (see section 'SUBMISSION ORGANIZATION AND INFORMATION REQUIREMENTS').

ONLY ELECTRONIC LOIS WILL BE ACCEPTED.

LOIs should be submitted in .pdf format using software such as Adobe, CutePDF PDF Writer, Docudesk deskPDF, etc.

One copy of the LOI should be sent as a .pdf file, <u>through NCDOT's FTS System</u>, to: <u>cjcoughlin@ncdot.gov</u>. The FTS system will send you an electronic receipt when your LOI is <u>uploaded</u> to NCDOT's FTS system. Paper copies are not required. The subject line should contain the Firm's Name, and "LOI for 2018-2019 On-Call Right of Way Services".

If an interested firm does not have an FTS account they should send a request through regular email to <u>cicoughlin@ncdot.gov</u>. A response will be sent via the FTS system that will provide a login username, password, and login procedures. LOIs SHALL be received electronically no later than 12:00 P.M., July 31, 2018.

LOIs received after this deadline will not be considered.

Firms submitting LOIs are encouraged to carefully check them for conformance to the requirements stated above (and any other requirements in this Advertisement). If LOIs are submitted late, exceed the maximum number of pages, are sent by any means other than NCDOT's FTS system, or are sent to any address other than cjcoughlin@ncdot.gov they will be disgualified.

The Department reserves the right to reject all LOIs and not proceed with procurement.

The Department reserves the right to waive any technicality in LOIs, or notify the Firm(s) of such technicality and allow the Firm(s) up to two (2) business days to rectify the technicality.

SELECTION PROCESS

Following is a general description of the selection process:

- The NCDOT Selection Committee will review all qualifying LOI submittals.
- For Limited Services Contracts (On-Call type contracts), the NCDOT Selection Committee MAY, at the Department's discretion, choose any number of firms to provide the services being solicited.
- In order to be considered for selection, consultants must submit a complete response to this RFLOI prior to the specified deadlines. Failure to submit all information in a timely manner will result in disqualification.

SMALL PROFESSIONAL SERVICE FIRM (SPSF) PARTICIPATION

The Department encourages the use of Small Professional Services Firms (SPSF). Small businesses determined to be eligible for participation in the SPSF program are those meeting size standards defined by Small Business Administration (SBA) regulations, 13 CFR Part 121 in Sector 54 under the North American Industrial Classification System (NAICS). The SPSF program is a race, ethnicity, and gender neutral program designed to increase the availability of contracting opportunities for small businesses on federal, state or locally funded contracts. SPSF participation is not contingent upon the funding source.

The Firm, at the time the Letter of Interest is submitted, shall submit a listing of all known SPSF firms that will participate in the performance of the identified work. The participation shall be submitted on the Department's Sub-consultant Form RS-2. RS-2 forms may be accessed on the Department's website at <u>NCDOT Electronic Forms</u>.

The SPSF must be qualified with the Department to perform the work for which they are listed.

Real-time information about firms doing business with the Department and firms that are SPSF certified through the Contractual Services Unit is available in the Directory of Transportation Firms.

The Directory can be accessed on the Department's website at <u>Directory of Firms</u> -- Complete listing of certified and prequalified firms.

The listing of an individual firm in the Department's directory shall not be construed as an endorsement of the firm.

PREQUALIFICATION

The Department maintains on file the qualifications and key personnel for each approved discipline, as well as any required samples of work. Each year on the anniversary date of the company, the firm shall renew their prequalified disciplines. If your firm has not renewed its application as required by your anniversary date or if your firm is not currently prequalified, please submit an application to the Department **prior to submittal of your LOI**. An application may be accessed on the Department's website at <u>Prequalifying Private Consulting Firms</u> -- Learn how to become Prequalified as a Private Consulting Firm with NCDOT. Having this data on file with the Department eliminates the need to resubmit this data with each letter of interest.

Even though specific DBE/MBE/WBE goals are not required for this project, the Department of Transportation is committed to providing opportunity for small and disadvantaged businesses to perform on its contracts through established Department goals. The Firm, sub-consultant and sub-firm shall not discriminate on the basis of race, religion, color, national origin, age, disability or sex in the performance of this contract.

SELECTION CRITERIA

All prequalified firms who submit responsive letters of interest will be considered.

In selecting a firm/team, the selection committee will take into consideration qualification information including such factors as:

- 1. <u>40%</u> = The consultants' right of way expertise and staff experience (including subcontractors) to perform the type of work required.
- 2. <u>40%</u> = The consultants' ability to meet the time schedule established for the work based on the ability of proposed staff and current work load.
- 3. <u>20%</u> = The consultants should provide with this submittal the expertise in each of the right of way disciplines; also specific experience in Rail Acquisition.

After reviewing qualifications, if firms are equal on the evaluation review, then those qualified firms with proposed SPSF participation will be given priority consideration.

SUBMISSION ORGANIZATION AND INFORMATION REQUIREMENTS

The LOI should be addressed to **Mr. Chris Coughlin – NCDOT Right of Way Unit** and must include the name, address, telephone number, and e-mail address of the prime consultant's contact person for this RFLOI.

The LOI must also include the information outlined below:

Chapter 1 - Introduction

The Introduction should demonstrate the consultant's overall qualifications to fulfill the requirements of the scope of work and should contain the following elements of information:

- Expression of firm's interest in the work;
- Statement of whether firm is on register;
- Date of most recent firm qualification;
- Statement regarding firm's(') possible conflict of interest for the work; and
- Summation of information contained in the letter of interest.

Chapter 2 - Team Qualifications

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- 1. Identify <u>recent</u>, similar projects the firm, acting as the prime contractor, has conducted which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed, and contact person.
- 2. If sub-consultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

Chapter 3 - Team Experience

This chapter must provide the names, classifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project. Specifically, the Department is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project / Plan. A Capacity Chart / Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

<u>Note:</u> If a project team or sub-consultant encounters personnel changes, or any other changes of significance dealing with the company, NCDOT should be notified immediately.

Chapter 4 - Technical Approach

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).
