The Engineers performing the work and in responsible charge of the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest. Firms which are not providing engineering services need not be registered with the North Carolina Board of Examiners for Engineers and Surveyors. - 1. The GESC Firm (prime firm and all sub-consultants) will be precluded, in perpetuity, from working for, or advising, any contractor or firm 1) pursing this Design-Build project or 2) under contract for this Design-Build project.
- 2. GESC Firm personnel will not be a part of any Technical Review Committee (TRC) but may serve as advisors to the TRCs, as designated by NCDOT.
- 3. Confidentiality agreements will be required to be executed among the GESC Firm, NCDOT and all GESC sub-consultants.
- 4. All review comments generated by this contract shall be provided directly to the Division. Under no circumstances will there be any consultant to consultant contact with regard to review of work products generated by other consultants.
- 5. Nothing in the above restrictions is intended to preclude the GESC Firm or its sub-consultants from pursuing or engaging in other work directly contracted by and between the GESC Firm or its sub-consultants and the NCDOT (e.g. performance of CEN for projects, including ADPs).

PROJECT MANAGER

The GESC Firm is intended to augment the capacity and capabilities of NCDOT staff to deliver the Division Design-Build Project using alternative delivery methods. Therefore, the dedicated project manager is expected to have the following knowledge, skills and abilities:

- Ability to provide or secure technical design and environmental services expertise across all modes in support of ADP procurement documents and design approvals;/
- Experience with alternative delivery methods and processes;
- Project management, scheduling, tracking and performance measurement capability;
- Ability to effectively communicate (written and verbal) with internal and external stakeholders/partners;

SELECTION CRITERIA

All prequalified firms who submit responsive letters of interest will be considered.

In selecting a firm/team, the selection committee will take into consideration qualification information including such factors as:

- 20% = Experience, qualifications, and technical competence of the staff proposed;
 breadth of expertise of the firm including national involvement in Design Build Projects.
- 2. <u>30%</u> = Past performance of the firm. Track record of the firm's ability to provide satisfactory NCDOT client support under a multi-year contract.
- 3. <u>15%</u> = Responsiveness to the NCDOT, and the availability/readiness of the proposed staff.
- 4. **20%** = Familiarity of the firm with NCDOT practices and procedures, including Design-Build projects.
- 5. <u>15%</u> = Team composition and extent of prequalification across various disciplines.

After reviewing qualifications, if firms are equal on the evaluation review, then those qualified firms with proposed SPSF participation will be given priority consideration.

Chapter 2 - Team Qualitications

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- 1. Identify recent, similar projects the firm, acting as the prime contractor, has conducted which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed, and contact person.
- 2. If subconsultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

Chapter 3 - Team Experience

This chapter must provide the names, Alassifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project. Specifically, the Department is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project / Plan. A Capacity Chart / Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

Note: If a project team or subconsultant encounters personnel changes, or any other charges of significance dealing with the company, NCDOT should be notified immediately.

Chapter 4 -Technical Approach

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).
