A – An electronic copy and five (5) paper copies are required. As noted on Page 6 of the RFLOI, Five (5) total copies of the LOI should be submitted. The requirement on Page 4 stating "Electronic LOIs shall be submitted in .pdf format using software such as Adobe, CutePDF, PDF Writer, Docudesk, deskPDF, etc." is in addition to the 5 paper copies. Delivery instructions for both paper copy and electronic copy are provided on page 4.

 ${\bf Q}$ – In looking at the Prequal Codes required. For 00013 – Appraisal Review – on the NCDOT website code 13 is shown in the following way 00013APPRAISAL REVIEWS (DOT STAFF ONLY) not sure if that means only DOT staff are able to do this. For 00030 – Capacity Analysis – Roundabouts- that code is no longer active.

A – Discipline Codes 00013 and 00030 are deleted from this RFLOI.

The solicitation, selection, and negotiation of a contract shall be conducted in accordance with all Department requirements and guidelines.

This RFLOI is to solicit responses (LETTERS of INTEREST, or LOIs) from qualified firms to provide professional consulting services to:

PROPOSED CONTRACT SCOPE SUMMARY

Perform professional engineering design, land surveying, subsurface utility engineering, geotechnical investigations, cost estimation, project management, environmental documentation and permitting, public engagement, and right of way acquisition on Federally Funded Projects.

The Town intends to select a minimum of three (3) qualified firms to perform these services on multiple various projects under an on-call contract. It is the Town's intent that qualified firms will be selected in a rotational order to perform work. This solicitation does not imply or guarantee a work duration, monetary value, or any work. The on-call contract will have a two-year duration with the ability to be extended up to one (1) additional year.

While all potential projects planned for delivery through contracts resulting from this oncall selection have not been identified, projects of the following scope are typical and should be represented in your letter of interest:

- 1. intersection operational improvements by addition of traffic signals with minor widening or roadway realignment
- 2. intersection operational improvements by construction of a roundabout
- 3. pedestrian improvements by infill of a sidewalk gap with minor road widening
- 4. pedestrian safety ADA upgrades

5. pedestrian facilities including greenways with intermittent boardwalks

LOIs received after this deadline will not be considered.

Except as provided below any firm wishing to be considered must be properly registered with the Office of the Secretary of State and with the North Carolina Board of Examiners for Engineers and Surveyors. Any firm proposing to use corporate subsidiaries or subcontractors must include a statement that these companies are properly registered with the North Carolina Board of Examiners for Engineers and Surveyors and/or the NC Board for Licensing of Geologists. The Engineers performing the work and in responsible charge of the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest. Firms which are not providing engineering services need not be registered with the North Carolina Board of Examiners for Engineers and Surveyors. Some of the services being solicited may not require a license. It is the responsibility of each firm to adhere to all laws of the State of North Carolina.

The firm must have the financial ability to undertake the work and assume the liability. The selected firm(s) will be required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00. The firm(s) must have an adequate accounting system to identify costs chargeable to the project.

SCOPE OF WORK

The **Town of Fuquay-Varina** is soliciting proposals for the services of a firm/team for the following contract scope of work:

PROPOSED CONTRACT SCOPE

The project(s) will include some or all of the following elements: transportation engineering; roadway design; pavement design; land surveying for topographic mapping and right of way boundary determination, acquisition plat preparation and legal descriptions; right of way acquisition and relocation services; subsurface utility engineering and coordination (QL-A geotechnical investigations and recommendations, NEPA documentation and compliance reporting; hydrology/hydraulic studies, erosion control plans; traffic management plans, and production of construction documents, cost estimates, and final record drawings for comprehensive improvements to the street including design of improvements for traffic signals, pavement widening, roundabouts, pedestrian signals, sidewalk and streetscapes/landscapes, pavement resurfacing, multi-use paths, bicycle facilities, pedestrian safety, stormwater collection, small bridge or culvert design, and water system and/or sanitary sewer relocation. Other related services which may be required are underground structure design; Low Impact Design for urban stormwater infrastructure; public engagement and stakeholder meeting coordination and presentation, state agency permitting, and if the project advances bidding and construction phase engineering support services.

This project will require the services of a professional engineer in a prime role to complete all services. All design plans must be sealed by a professional qualified to perform such services. The plans for the work listed above shall be prepared in electronic format and shall be compatible with the current NCDOT software (Corridor Modeling, Microstation/Geopak Civil Software) however, plans shall also be made available to the Town in Autodesk AutoCAD format.

Selected consultants will enter into a Professional Services Agreement similar to the example provided in the Appendices. A schedule of currently approved CRS hourly staff rates and overhead percentages along with the CRS renewal date shall be provided as an exhibit to the agreement. For proposed project assignments once contracted with the Town, selected consultants will be required to submit detailed scope and fee breakdowns. Scope and fee for each project assignment will be subject to approval and negotiation with the Town. Fee proposals shall be provided in the most-current version of the NCDOT Scope and Manday Estimate Form (spreadsheet) and will be subject to NCDOT approval. Scope descriptions shall include detailing of the delivery schedule, deliverable products, and any key assumptions by the Consultant.

PROPOSED CONTRACT TIME: The on-call contract will have a two-year duration with the ability to be extended up to one (1) additional year at Town's sole discretion.

PROPOSED CONTRACT PAYMENT TYPE: The contract payment type will be Lump Sum.

SUBMITTAL REQUIREMENTS

All LOIs are limited to **FIFTEEN** (15) pages (RS-2 forms and CRS rate sheets are not included in the page count) inclusive of the cover sheet and shall be typed on 8-1/2" x 11" sheets, single-spaced, one-sided, size 12 font.

Fold out pages <u>are not</u> allowed. In order to reduce costs and to facilitate recycling; binders, dividers, tabs, etc. are prohibited. One staple in the upper left-hand corner is preferred.

LOIs containing more than **FIFTEEN** (15) pages will not be considered.

Five (5) total copies of the LOI should be submitted.

Firms submitting LOIs are encouraged to carefully check them for conformance to the requirements stated above. If LOIs do not meet ALL of these requirements, they will be disqualified. No exception will be granted.

SELECTION PROCESS

Following is a general description of the selection process:

- The Town's Selection Committee will review all qualifying LOI submittals.
- The Town's Selection Committee may, at the Town's discretion, choose any number of firms to provide the services being solicited.
- To be considered for selection, consultants must submit a complete response to this RFLOI prior to the specified deadlines. Failure to submit all information in a timely manner will result in disqualification.

TITLE VI NONDISCRIMINATION NOTIFICATION

The Department encourages the use of Small Professional Services Firms (SPSF). Small businesses determined to be eligible for participation in the SPSF program are those meeting size standards defined by Small Business Administration (SBA) regulations, 13 CFR Part 121 in Sector 54 under the North American Industrial Classification System (NAICS). The SPSF program is a race, ethnicity, and gender neutral program designed to increase the availability of contracting opportunities for small businesses on federal, state or locally funded contracts. SPSF participation is not contingent upon the funding source.

The Firm, at the time the Letter of Interest is submitted, shall submit a listing of all known SPSF firms that will participate in the performance of the identified work. The participation shall be submitted on the Department's Subconsultant Form RS-2. RS-2 forms may be accessed on the Department's website at NCDOT Connect Guidelines & Forms.

The SPSF must be qualified with the Department to perform the work for which they are listed.

PREQUALIFICATION

The Department maintains on file the qualifications and key personnel for each approved discipline, as well as any required samples of work. Each year on the anniversary date of the company, the firm shall renew their prequalified disciplines. If your firm has not renewed its application as required by your anniversary date or if your firm is not currently prequalified, please submit an application to the Department **prior to submittal of your LOI**. Having this data on file with the Department eliminates the need to resubmit this data with each letter of interest.

Professional Services Contracts are race and gender neutral and do not contain goals. However, the Respondent is encouraged to give every opportunity to allow Disadvantaged, Minority-Owned and Women-Owned Business Enterprises (DBE/MBE/WBE) subconsultant utilization on all LOIs, contracts and supplemental agreements. The Firm, subconsultant and subfirm shall not discriminate on the basis of race, religion, color, national origin, age, disability or sex in the performance of this contract.

In selecting a firm/team, the selection committee will take into consideration qualification information including such factors as:

After reviewing qualifications, if firms are equal on the evaluation review, then those qualified firms with proposed SPSF participation will be given priority consideration.

SUBMISSION ORGANIZATION AND INFORMATION REQUIREMENTS

Chapter 1 - Introduction

The Introduction should demonstrate the consultant's overall qualifications to fulfill the requirements of the scope of work and should contain the following elements of information:

- Expression of firm's interest in the work;
- Statement of whether firm is on register;
- Date of most recent private engineering firm qualification;
- Statement regarding firm's(') possible conflict of interest for the work; and
- Summation of information contained in the letter of interest.

Chapter 2 - Team Qualifications

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- 1. Identify <u>recent</u>, similar projects the firm, acting as the prime contractor, has conducted which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed, and contact person.
- 2. If subconsultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

Chapter 3 - Team Experience

This chapter must provide the names, classifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project. Specifically, the Department is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The

submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project / Plan. A Capacity Chart / Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

<u>Note:</u> If a project team or subconsultant encounters personnel changes, or any other changes of significance dealing with the company, the Town should be notified immediately.

Chapter 4 - Technical Approach

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).
