SYNOPSIS

The City of Durham desires to engage a qualified <u>Private Engineering Firm (Firm)</u> in the role of "Prime" to provide Construction Engineering and Inspection (CEI) services for two separate roadway striping projects. This Request for Letters of Interest (RFLOI) is open only to firms pre-qualified as a Private Consulting Firm with NCDOT. The City intends to contract with one firm by way of two separate contracts under this advertisement. Both projects are dually funded with federal Transportation Alternative Program and City of Durham Capital Improvement Project dollars.

SUB CONSULTANTS ARE PERMITTED UNDER THIS CONTRACT

This contract will be partially reimbursed with Federal Highways Administration (FHWA) Federal-aid administered by the North Carolina Department of Transportation (NCDOT). The solicitation, selection, and negotiation of a contract shall be conducted in accordance with all NCDOT requirements and guidelines.

Firms shall demonstrate proficiency in the management of Federally Funded/Locally Managed projects as well as <u>Durham City/County Inspections</u>, <u>Construction Permit approvals</u>. Submittal teams shall demonstrate previous experience in the planning, administration and inspection of similar infrastructure striping projects.

The primary and/or subconsultant firm(s) shall be pre-qualified to perform the work codes listed below for the NCDOT:

LOIs received after August 20, 2020 will not be considered.

Except as provided below any Prime wishing to be considered must be properly registered with the Office of the Secretary of State and with the North Carolina Board of Examiners for Engineers and Surveyors. Any Prime proposing to use corporate subsidiaries or subcontractors must include a statement that these companies are properly registered with the North Carolina Board of Examiners for Engineers and Surveyors. The Engineers performing the work and in responsible charge of the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private Prime to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of Interest. Firms which are not providing engineering services need not be registered with the North Carolina Board of Examiners for Engineers and Surveyors. Some of the services being solicited may not require a license. It is the responsibility of each firm to adhere to all laws of the State of North Carolina.

The Firm must have the financial ability to undertake the work and assume the liability. The selected Prime will be required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00. The firm(s) must have an adequate accounting system to identify costs chargeable to the project.

The Project(s) involves the planning, layout and installation/application of roadway markings and ground mounted signage establishing bike lanes on various roads around the City. The Firm selected will be responsible for providing engineers and technicians with the appropriate skills and qualifications to ensure contract compliance. The Prime will be directly responsible for oversight of the projects for the City. The Firm shall indemnify and save harmless the City for claims and liabilities resulting from negligence, errors or omissions of the Prime; including, but not limited to, the engineers, technicians or subconsultants.

The Firm must demonstrate the ability to provide Construction Technicians with the appropriate skills and qualifications to perform inspection, materials sampling, materials testing, documentation of pay quantities, permit compliance, safety compliance and claims avoidance.

The technicians performing the inspection work must be NCDOT certified to perform materials sampling and testing or be able to obtain provisional certifications based on their combination of education, training and experience.

The scope of work for each project includes, but is not limited to, the following tasks;

- 1) <u>Project Review and Planning</u> The Project Documents, drawings and specifications, have been prepared by ALTA ENGINEERING of Durham, North Carolina for each segment of the Project(s). The Prime Firm will review and become familiar with all construction documents:
- 2) <u>Bidding</u> The Firm selected shall be available during the City-lead construction Pre-Bid Meeting;
- 3) <u>Construction</u> The Firm selected shall coordinate the construction/installation schedule with the Contractor, City and NCDOT; provide construction observation and inspection services so as to administer the contract and to ensure all work is completed in accordance with the construction documents.

PROPOSED CONTRACT TIME

The City of Durham will move expeditiously towards construction completion in early 2021. Submittals shall describe a proposed schedule for the project(s) and how the Firm, working with the Contractor, plans to complete the work. Sufficient time should be given to evaluating existing conditions, design requirements, permit approvals and bidding. The City and selected Firm will discuss the contract period during negotiations.

PROPOSED CONTRACT PAYMENT TYPE

It is the City's intention to use the contract template in the ATTACHMENTS section for both projects. After selections are made, the City will negotiate fair and reasonable compensation with the selected Firm. Compensation will include negotiation of profit as a separate element of price as per 2 CFR 200.323(b). If the compensation amount cannot be successfully negotiated, the City will begin compensation negotiations with the next Firm in line, and so on.

The proposed method of payment for this contract is a **Cost-Plus** basis. Progress payments will be made on a monthly or bi-monthly basis.

SUBMITTAL REQUIREMENTS

A Firm wishing to submit an LOI, **MUST** contact a Project Manager and register as an interested CEI. Information, such as Zoom Meeting information for the Pre-Submittal Meeting, will be transmitted to registered Firms only.

All LOIs are limited to **FIFTEEN (15)** pages (RS-2 forms are not included in the page count) inclusive of the cover sheet, and shall be on 8-1/2" x 11" sheets, single-spaced, one-sided. Minimum font size: **11 point**.

LOIs containing more than FIFTEEN (15) pages will not be considered.

LOIs are to be submitted **electronically** in **.pdf** format using software such as Adobe, CutePDF, PDF Writer, Docudesk deskPDF, etc.

Firms submitting LOIs are encouraged to carefully check them for conformance to the requirements stated above. If LOIs do not meet ALL of these requirements they will be disqualified. No exception will be granted.

IF APPLICABLE, dates of shortlisting and dates for interviews are shown in the section <u>SUBMISSION SCHEDULE AND KEY DATES</u> at the end of this RFLOI.
- <u>In order to be considered for selection</u>, Firms must submit a complete response to this RFLOI prior to the specified deadlines. Failure to submit all information in a timely manner will result in disqualification.
- <u>The City will select a private</u> engineering firm as Prime to provide the Construction Engineering and Inspection Services.
- All Firms who submitted LOIs will be notified whether or not they were selected. Firms may request a brief feedback phone call.

The SPSF program is a race, ethnicity, and gender neutral program designed to increase the availability of contracting opportunities for small businesses on federal, state or locally funded contracts. SPSF participation is not contingent upon the funding source.

The Firm, at the time the Letter of Interest is submitted, shall submit a listing of all known SPSF firms that will participate in the performance of the identified work. The participation shall be submitted on the Department's Subconsultant Form RS-2. RS-2 forms may be accessed on the Department's website at NCDOT Connect Guidelines & Forms.

The SPSF must be qualified with the Department to perform the work for which they are listed.

PREQUALIFICATION

The Department maintains on file the qualifications and key personnel for each approved discipline, as well as any required samples of work. Each year on the anniversary date of the company, the firm shall renew their prequalified disciplines. If your firm has not renewed its application as required by your anniversary date or if your firm is not currently prequalified, please submit an application to the Department prior to submittal of your LOI. An application may be accessed on the Department's website at Prequalifying Private Consulting Firms -- Learn how to become Prequalified as a Private Consulting Firm with NCDOT. Having this data on file with the Department eliminates the need to resubmit this data with each letter of interest.

Professional Services Contracts are race and gender neutral and do not contain goals. However, the Respondent is encouraged to give every opportunity to allow Disadvantaged, Minority-Owned and Women-Owned Business Enterprises (DBE/MBE/WBE) subconsultant utilization on all LOIs, contracts and supplemental agreements. The Firm, subconsultant and subfirm shall not discriminate on the basis of race, religion, color, national origin, age, disability or sex in the performance of this contract.

PROJECT GOALS

There are no assigned goals for this project. The City of Durham Department of Equity and Inclusion (E and I) strives to promote their Equal Business Opportunity Program. It is the policy of the City to provide equal opportunities for City contracting for underutilized firms owned by minorities and women doing business in the City's Contracting Marketplace. It is further the policy of the City to prohibit discrimination against any firm in pursuit of these opportunities.

The City has provided a listing of HUB firms that can be used on the Projects. The listing is not inclusive of all UBE firms that could participate. Primary Firms are encouraged to utilize these UBE firms wherever possible.

SELECTION CRITERIA

All firms who meet qualification requirements and submit complete Letters of Interests by the stated deadline will be considered. In selecting a firm/team, the Selection Committee will consider the following:

- 40% Experience working on Federally Funded projects managed by a Local Government. Demonstrated bike boulevards and bike lane design experience.
- 25% Management, Team Organization, Key Team Members, and Project Approach. Overall understanding of objectives and constraints. Proposed QA/QC program, use of technology, and community engagement.
- 15% Experience achieving concurrence and regulatory approvals from State and Local agencies; NCDOT, USACE, NCDEQ, Durham City/County Planning, etc.
- 15% Demonstrated ability to meet reference project schedules and budgets. Low rate of design errors and omissions.
- 5%: Other factors as determined by the Selection Committee (Examples: references, presentation quality, responsiveness, etc.)

After reviewing qualifications, if firms are equal on the evaluation review, then those qualified firms with proposed SPSF participation will be given priority consideration.

The LOI must also include the information outlined below:

Chapter 1 - Introduction

The Introduction should demonstrate the consultant's overall qualifications to fulfill the requirements of the scope of work and should contain the following elements of information:

- Name of Prime Firm
- Name, Address, Phone Number and e-mail of the Prime Consultant's Contact
- Expression of firm's interest in the work;
- Statement of whether firm is prequalified with NCDOT for the required work codes, or date of a specific NCDOT prequalification work code application;
- Date of most recent private engineering firm qualification;
- Statement regarding firm's(') possible conflict of interest for the work; and
- Summation of information contained in the letter of interest.

Chapter 2 - Team Qualifications

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- Identify <u>recent</u>, similar projects the firm, acting as the prime contractor, has conducted which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed, and contact person.
- If subconsultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

Chapter 3 - Team Experience

This chapter must provide the names, classifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project. Specifically, the Department is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project / Plan. A Capacity Chart / Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

Note: If a project team or subconsultant encounters personnel changes, or any other changes of significance dealing with the company, NCDOT should be notified immediately.

Chapter 4 - Technical Approach

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).
