See attached clarifications or changes, which are hereby made to the bid specifications and requirements:

- 1. **Q:** We believe some codes shown on the advertisement are not accurate and wanted to request removal of the following codes if the City concurs. As a sidewalk project (even with federal funds) this job will qualify for a categorical exclusion (Code 32). These two codes are for much larger projects, and are not needed:
  - 63 EA/FONSI
  - 66 EIS/ROD

Also, the code "116 – Indirect and Cumulative Effects Assessment" is typically used for long term land use questions related to the alternative. This corridor is already developed. Does the City intend to change this? If not, the code is not needed.

## **SYNOPSIS**

## SUBCONSULTANTS ARE PERMITTED UNDER THIS CONTRACT.

This contract shall be partially reimbursed with Federal-aid funding through the North Carolina Department of Transportation (hereinafter referred to as the Department). The solicitation, selection, and negotiation of a contract shall be conducted in accordance with all Department requirements and guidelines.

The Jonestown Road Sidewalk project will provide civil and roadway design services for a continuous 6' wide sidewalk on both sides of the approximately 0.5-mile section of Jonestown Road between Salem Parkway (US 421 NB Ramp) and Country Club Road. The project deliverables must include utility-make-ready and traffic control plans to facilitate the construction of the proposed sidewalk. The project is expected to provide connectivity to existing sidewalk infrastructure in place within the project limits and provide a connection to the existing sidewalk along Country Club Road at the northernmost project limit.

Electronic LOIs should be submitted in .pdf format using software such as Adobe, CutePDF PDF Writer, Docudesk deskPDF, etc.

### LOIs received after this deadline will not be considered.

Except as provided below any firm wishing to be considered must be properly registered with the Office of the Secretary of State and with the North Carolina Board of Examiners for Engineers and Surveyors. Any firm proposing to use corporate subsidiaries or subcontractors must include a statement that these companies are properly registered with the North Carolina Board of Examiners for Engineers and Surveyors and/or the NC Board for Licensing of Geologists. The Engineers performing the work and in responsible charge of the work must be registered Professional Engineers in the State of North Carolina and must have a good ethical and professional standing. It will be the responsibility of the selected private firm to verify the registration of any corporate subsidiary or subcontractor prior to submitting a Letter of

Interest. Firms which are not providing engineering services need not be registered with the North Carolina Board of Examiners for Engineers and Surveyors. Some of the services being solicited may not require a license. It is the responsibility of each firm to adhere to all laws of the State of North Carolina.

The firm must have the financial ability to undertake the work and assume the liability. The selected firm(s) will be required to furnish proof of Professional Liability insurance coverage in the minimum amount of \$1,000,000.00. The firm(s) must have an adequate accounting system to identify costs chargeable to the project.

# SCOPE OF WORK

The **City of Winston-Salem** is soliciting proposals for the services of a firm/team for the following contract scope of work:

- Fully design the Jonestown Road sidewalk project which consists of the construction of sidewalk east of 421 to SR 1001 (Country Club Road); which is the east and west side of Jonestown Road in Winston-Salem, NC
- Development of preliminary design and assistance with other tasks related to the preliminary engineering and right of way acquisition phases of Federal or State funded projects.
- Design and construction engineering of sidewalks and various and pedestrian facilities.
- Public outreach and involvement
- Coordination with the City of Winston-Salem and utility providers
- Project management

## PROPOSED CONTRACT PAYMENT TYPE: LUMP SUM

## SUBMITTAL REQUIREMENTS

All LOIs are limited to **fifteen** (**15**) pages (RS-2 forms are not included in the page count) inclusive of the cover sheet and shall be typed on 8-1/2" x 11" sheets, single-spaced, one-sided.

Fold out pages <u>are not</u> allowed. In order to reduce costs and to facilitate recycling; binders, dividers, tabs, etc. are prohibited. One staple in the upper left-hand corner is preferred.

LOIs containing more than **fifteen** (15) pages will not be considered.

## One (1) total copies of the LOI should be submitted.

Firms submitting LOIs are encouraged to carefully check them for conformance to the requirements stated above. If LOIs do not meet ALL of these requirements they will be disqualified. No exception will be granted.

# SELECTION PROCESS

Following is a general description of the selection process:

- The LGA's Selection Committee will review all qualifying LOI submittals.
- <u>For Limited Services Contracts (On-Call type contracts)</u>, the LGA's Selection Committee <u>MAY</u>, at the LGA's discretion, choose any number of firms to provide the services being solicited.
- For Project-Specific Contracts (non On-Call type contracts), the LGA's Selection Committee <u>MAY</u>, at the LGA's discretion, shortlist a minimum of three (3) firms to be interviewed. IF APPLICABLE, dates of shortlisting and dates for interviews are shown in the section <u>SUBMISSION SCHEDULE AND KEY DATES</u> at the end of this RFLOI.
- In order to be considered for selection, consultants must submit a complete response to this RFLOI prior to the specified deadlines. Failure to submit all information in a timely manner will result in disqualification.

# **SELECTION CRITERIA**

## All prequalified firms who submit responsive letters of interest will be considered.

In selecting a firm/team, the selection committee will take into consideration qualification information including such factors as:

- 1. <u>40%</u> = Work Experience
- 2. <u>30%</u> = Staff/Team Qualifications
- 3. 20% = Technical Approach
- 4. <u>10%</u> = Staff Availability

After reviewing qualifications, if firms are equal on the evaluation review, then those qualified firms with proposed SPSF participation will be given priority consideration.

The LOI should be addressed to **Will Cave, Civil Engineer** and must include the name, address, telephone number, and e-mail address of the prime consultant's contact person for this RFLOI.

The LOI must also include the information outlined below:

Chapter 1 - Introduction

The Introduction should demonstrate the consultant's overall qualifications to fulfill the requirements of the scope of work and should contain the following elements of information:

- Expression of firm's interest in the work;
- Statement of whether firm is on register;
- Date of most recent private engineering firm qualification;
- Statement regarding firm's(') possible conflict of interest for the work; and
- Summation of information contained in the letter of interest.

#### Chapter 2 - Team Qualifications

This chapter should elaborate on the general information presented in the introduction, to establish the credentials and experience of the consultant to undertake this type of effort. The following must be included:

- 1. Identify <u>recent</u>, similar projects the firm, acting as the prime contractor, has conducted (within the past 5 years) which demonstrates its ability to conduct and manage the project. Provide a synopsis of each project and include the date completed, and contact person.
- 2. If subconsultants are involved, provide corresponding information describing their qualifications as requested in bullet number 1 above.

#### Chapter 3 - Team Experience

This chapter must provide the names, classifications, and location of the firm's North Carolina employees and resources to be assigned to the advertised work; and the professional credentials and experience of the persons assigned to the project, along with any unique qualifications of key personnel. Although standard personnel resumes may be included, identify pertinent team experience to be applied to this project. Specifically, the Department is interested in the experience, expertise, and total quality of the consultant's proposed team. If principals of the firm will not be actively involved in the study/contract/project, do not list them. The submittal shall clearly indicate the Consultant's Project Manager, other key Team Members and his/her qualifications for the proposed work. Also, include the team's organization chart for the Project / Plan. A Capacity Chart / Graph (available work force) should also be included. Any other pertinent information should also be listed in this section.

**<u>Note:</u>** If a project team or subconsultant encounters personnel changes, or any other changes of significance dealing with the company, NCDOT should be notified immediately.

#### Chapter 4 - Technical Approach

The consultant shall provide information on its understanding of, and approach to accomplish, this project, including their envisioned scope for the work and any innovative ideas/approaches, and a schedule to achieve the dates outlined in this RFLOI (if any project-specific dates are outlined below).

- 90% Plans (~2 months after 60% plans)
- 100% Plans (~1 months after 90% plans)
