The following changes are made to the above referenced proposal for **Professional Landscape Plant Bed and Mowing Maintenance in Camden, Currituck, Dare, Pasquotank and Perquimans Counties.**

1. Delete Page 37: **APPENDIX** Dare County, near the Kitty Hawk Rest Area paragraph and photo:

Dare County, near the Kitty Hawk Rest Area—at the intersection of US158 and NC12, maintain perennial, shrub and tree planting beds, one in the northwest quadrant and one in the north east quadrant. On the northwest quadrant, mow 15' around the bed. On the northeast quadrant, mow from the edge of pavement to 15' beyond the back edge of the bed. **Mulched area is 5,479 square yards.**



2. Amend page 40 APPENDIX Camden County, on US17 North of the Dismal Swamp Rest Area/Visitor Center to Virginia Line as follows:

Camden County, on US17 North of the Dismal Swamp Rest Area/Visitor Center to Virginia Line, there are 3 plant beds to be maintained. Each bed is 300' long and is planted with Crape Myrtles and daylilies. At each bed, mow from edge of pavement to edge of pavement on both sides of the beds and ~~250'~~ **50'** beyond the ends of the bed. Mulched area is 1474 square yards. (*No photo.*)

3. Amend page 40 APPENDIX Pasquotank County, on US17 and US17 Business, from the Camden County Line to the Perquimans County Line as follows:

Pasquotank County, on US17 and US17 Business, from the Camden County Line to the Perquimans County Line, in divided highway sections, maintain perennial, shrub and tree beds. ~~At each bed 150', mow from edge of pavement to edge of pavement and 250' beyond the ends of the bed.~~ **At each bed, mow from edge of pavement to edge of pavement and 50' beyond the ends of the bed, unless there is an intersection with 250 feet of the bed, then mow to the intersection.** In areas where beds are within 250' of each other, mow continuously between the beds. On SR1197, (Old US17), from near the intersection with US17 Business, maintain wax myrtle bed and mow from edge of pavement to Control of Access fence, beginning from 150' on both ends of the Wax Myrtle bed. Keep Control of Access fence clean of any unwanted vegetation. Mulched area is 9013 square yards. (*No photo.*)

4. Amend page 40 APPENDIX Perquimans County, Woodville, on US17 as follows:

Perquimans County, Woodville, on US17, mow grounds of the NC Dept. of Transportation Weigh Station. Mow from edge of pavement to the ditch and maintain ditch to keep free of unwanted vegetation. Contractor may not use herbicides to maintain vegetation in the ditch. Contractor shall use herbicides to keep paved areas and right around the building free of unwanted vegetation. Mow and Maintain plant beds on Hwy 17 from the Weigh Station to Pasquotank County line. **At each bed, mow from edge of pavement to edge of pavement and 50' beyond the ends of the bed, unless there is an intersection with 250 feet of the bed, then mow to the intersection. In areas where beds are within 250' of each other, mow continuously between the beds.** (*No photo.*)
