1	Mowing Equipment Restrictions	I want to make sure that I understand the equipment standards. Can half batwings be used on all highways? It does mention 15ft batwing restrictions but not other mowers.	Only flail mowers are to be used for this contract. No batwing or half-bat mowers will be allowed.

Question #	Solicitation Section	Vendor Question	State's Response
2	General Specifications	My other question is are they expecting to start in all 3 counties at the same time by requiring 3 trucks and supervisors or can we go county to county. Eight tractors could easily mow this amount miles easily in their time frame with one supervisor. Just would like to be clear because the price would be significantly higher with 3 trucks.	The contractor is not required to start in all three counties at the same time. The contractor can choose to start all 8 tractors in one county but is allowed to split the required minimum number (8) of tractors between the 3 counties and mow multiple counties at one time. If the contractor is actively mowing multiple counties, each county shall have a supervisor and service truck in that county. The bidders should be reminded of the LD's that will be incurred if they do not complete the cycles in the time allotted. They will not be allowed to use how the tractors were or were not split as justification for non-compliance.
