#### 1. Amend Page 13 by adding:

#### 2. Amend Page 19 as follows:

A. Mandatory Wage Rate: This contract includes requirements for a minimum mandatory wage rate of \$10.80 \$10.97 per hour for each attendant and \$13.80 \$13.97 per hour for the supervisor. This information shall be posted and a notice placed at each rest area, in the space utilized by the Contractor for posting of employee information, that the North Carolina Department of Labor should be notified by Contractor's employees if the mandatory wage rate is not being paid by the Contractor. The Contractor's written payroll schedule for the contract shall also be posted in this area.

#### 3. Amend Bid Submittal Page 8 of 17 as follows:

## MANDATORY MINIMUM WAGE RATE REQUIREMENT

### **February 1, 2021**

The Contractor is required to compensate rest area employees at the following wage rate. This is the <u>minimum</u> hourly wage rate that employees shall be paid.
