Bottle Filling Station Replacement Filter for Elkay Model LZWS-LRPBM28K.

3. Amend Page 24: K. Door Mats by replacing:

The Contractor shall provide a minimum of one (1) outdoor and one (1) indoor slip-resistant type doormats (4' x 6' or larger) to be used at each of the three (3) entrance doors of the service building.

The Contractor shall provide a minimum of one (1) outdoor and one (1) indoor slip-resistant type doormats (4' x 6' or larger) to be used at the two (2) side entrance doors and one (1) outdoor and one (1) indoor slip-resistant type doormats (4' x 8' or larger) to be used at the main entrance of the service building.
