# FAA AIG Grant Application and Expenditure Status

Please request all announced federal Airport Infrastructure Grant funding from your regional airport project manager as soon as possible. FFY 2022 AIG funds will be lost to your airport if you do not request them through application to your APM **by April 10, 2025**.

Applications must include:

- Approved Work Authorization, IFE & approved NEPA for Design grants
- Approved Work Authorization & IFE for Construction Admin & RPR services
- Final Bid estimate with minority goals set for construction. Bidding must occur during the application process to receive funds.
- Informal Bidding or Small Purchase contracts are eligible if utilizing FAA guidance: <u>https://www.faa.gov/airports/aip/procurement/small\_purchase</u>
- Closing Documents with NEPA complete for land acquisition
- FAA Form 5100-100

Please note that FAA has specified that each work type cost must be represented in the request. Example: Corporate Hangar might have an application for taxilane, apron, and hangar.

Contact your APM immediately if you have not designated how these funds will be spent.
