Impact Analysis Methodology

North Carolina State University's Institute for Transportation Research and Education (TREF) analyzed data from 2021, the most recent year complete data is available, primarily provided by North Carolina's 72 public service airports and the Federal Aviation Administration. If RE used the IMPLAN model to compute componic impact.

The commercial service an port analysis quantified the by business impacts of leisure and business travelers to North Carolina of visitors, and business travelers them North Carolina, on-airport

contributions (jobs, income and spending by lenants such as aritinos, rental car companies and airport security) and the impact of airport capital projects and operations (construction, facility maintenance and operational services).

The general aviation airport analysis quantified the impact of jobs supported by the airport directly, jobs supported by businesses that rely on the airport, and the impact of visitors.





AIRPORT TAKEOFFS AND LANDINGS JAN. 2019-JULY 2022








- Methodology changes:






