AIG Funding Overview

Tiered Grants for Each of Five Years

Airports must request announced funding from their airport project manager

As of March 4, only 10 of 61 eligible general aviation airports have requested AIG funds – a total of \$2,957,910 of the \$37,865,000 announced for N.C. airports.

- Bipartisan Infrastructure Law authorized tiered
 AIG public airport grants for each of 5 years
- NCDOT, as state block grant administrator, applies to FAA for AIG funds on behalf of N.C. general aviation airports
- NCDOT manages distribution, tracking and reporting
- Airports must annually declare how they intend to use AIG funds
- Airports must request funding, with documentation, to apply for announced funding

AIG projects must meet Airport Improvement Program and/or Passenger Facility Charge eligibility

- May not be used for debt service
- Contact your engineer of record for eligibility determinations





Requesting AIG Funding

Request funds with FAA FORM 5100-100 to your airport project manager, with the following documentation:



For Professional Services:

- Reviewed/approved and executed Work Authorization
- Completed Independent Fee Estimate

For Construction:

 Final construction estimate being advertised (FAA awards bid amount)

For Land Acquisition:


- Unexecuted closing document
- Note: Acquisition cost must be concurred upon with DOA and have landowner commitment prior to application

Request funds as soon as possible to ensure funds are obligated (under grant) by each fund year deadline

FFY 2022 funds must be obligated by September 30, 2025



- The FAA Airports District Office does not accept applications between July and October.
- The application and review process may take up to four months.
- Applications can be denied during the FAA review process, which can cause further delays with reapplying.
- Expiring AIG funds cannot be swapped.
