## Training Update

- **Project Development Roles and Responsibilities Training** – *initial training sessions have been held. Additional training classes are being scheduled for this June 24<sup>th</sup> and 25<sup>th</sup>.*
- **MS Project Schedule Training** – *initial training sessions are underway now. This training is intended for Preconstruction PMs, and consist of what is included in a schedule, why it is important, how to define the critical path, and how to utilize a schedule on a daily basis as a PM.*
- **NEPA/SEPA 101 Training** – *initial training sessions have been held. Additional training classes are scheduled for this summer. This general overview is intended for staff in Preconstruction roles, and consist of what elements are required for decision-making, including Scoping, Purpose and Need, Alternative Analysis, and Impact Avoidance. ## Bluebeam

**Want to Reduce your Review Comment Time by 30%?** The Department has acquired an enterprise license for Bluebeam Revu. Bluebeam Revu is a PDF creation, editing, markup and collaboration technology for design and construction workflows. Productivity may be increased by leveraging markup data across the entire project lifecycle and streamline processes to get more done in less time. NCDOT currently has a pool of 250 licenses that can be used at any given time. When Bluebeam is opened, a license is utilized. When Bluebeam is closed, that license is released back into the pool.
