**SUBJECT:** 2012 Highway Safety Improvement Program

The Traffic Safety Systems Section of the Transportation Mobility and Safety Division has completed the 2012 Highway Safety Improvement Program (HSIP) listing. The 2012 HSIP report and listings by county and location type are available on our website at <http://www.ncdot.gov/doh/preconstruct/traffic/safety/Programs/phreports.html>. Crash information contained in this report reflects only those crashes that were reported prior to January 1, 2012. Although only minor safety warrant changes have been incorporated into this cycle, we will continue to seek input from Regional Staff in this and other enhancement processes.

The HSIP Group has many important functions and continues to grow in new areas. However, our primary focus remains to develop and manage the Highway Safety Improvement Program and to respond to any request from Regional Staff. In this effort we will strive to provide locations for investigation that have promise for countermeasure implementation. Our staff is here to assist you with crash analyses, program or warrant clarifications, field investigations, project development and to help in any way with potentially hazardous locations or other requests.

Crash analyses from this listing will be sent electronically to the Regions starting this month. The detailed analyses will include TEAAS reports, crash copies, collision diagrams and response form.
