# **OVERVIEW OF THE RELEASE**

- Hicams Application enhancements in various modules related to Contract Maintenance, Contract Adjustment, Contract Estimates, Field Inspection Report, WBS Maintenance, Standard Reports, Reference (Test Format). Enhancements/fixes to the Moving Average Report,
- Data fixes for production issues in various modules

# **HiCAMS - General**

- Added logic to set the contract reset line item settings indicator to 'Y', if the fuel base price and or the asphalt base price changes. After changing fuel or asphalt base prices, the next estimate generated will go back and recalculate the Fuel and AC adjustments. – SQA 23651
- Added a warning message to notify user when there are any Advertised Goal values other then zero value is required in the corresponding Contract Goal field. SQA - 22759

#### **CONTRACT MAINTENANCE - Authorize Contracts**

 CCU request the Adjust Total AC Percent field be removed from the Authorize Contracts window and only displayed data on the Contract Details Financial tab. – SQA 23669

#### **CONTRACT ADJUSTMENTS - General**

 Added new code on the Supplemental Agreement Workflow window that would not allow users to enter a FHWA Concurrence status, before the SA has been approved - SQA 23050

#### **CONTRACT ESTIMATES - Review Estimates**

• FIX - Added new code to display the Contractor version of the Estimate data instead of displaying the Fiscal version of the data in the Contractor Estimate Report column on the Estimate File table. - SQA 23640

# **WBS MAINTENANCE - Split WBSs**

 Enhanced the messaging in WBS splits to encourage the users to be careful BEFORE completing the splits, message will ask if they are sure they want to Save transaction. – SQA 23663

# FIELD INSPECTION REPORTS (FIR) - Review Field Inspection Reports

 PLASTIC PIPE: Plastic Pipe – Corrected the misspelling word in the error message. – SQA 23535

#### STANDARD REPORTS

- CONTRACT OVERRUN/UNDERRUN COMPUTATION REPORT: Corrected the right margin on report, data was cut off. SQA 23557
- QAQC MOVING AVERAGE REPORT: Continue to improve the Moving Average Report, set the Minimum and Max Fields on the graph to default to the limits instead of sample values. – SQA 23531
- QAQC MOVING AVERAGE REPORT: Correct message spelling of word <u>PLEASE</u> on the Information message. – SQA 23556

#### **REFERENCES** - Test Formats

- Fix user values in window for test result mapping and exclude new test result tables from mapping table selection. When creating a new test result mapping for a new table, the User Value field ends up with the Label values instead of the USERXXX values. When creating a new mapping to a new table, the list of tables also includes all the new test result tables in addition to the mapping tables. The list will only show mapping tables. – SQA 23658
