# HiCAMS & DOH Vendor Version 8.7.2 were released Friday, 09/29/2023.

## OVERVIEW OF THE RELEASE

- Hicams Application enhancements in various modules related to AMD, Artemis, CMD, Estimates, JMF, Notifications, Pay Records, Plastic Pipe, Precast Concrete and Prestressed FIRs, Plastic Pipe, Precast Concrete and Prestressed FIRs, Product Maintenance, Query Tool, Standard Reports, Subcontracts, 2<sup>nd</sup> Tier Subcontracts, Test Formats,
- Vendor Application enhancements Product Maintenance & Producer Supplier
- Data fixes for production issues in various modules

#### HiCAMS - General

- Updated the HiCAMS Help Message by removing the HiCAMS Helpdesk Phone Number, replaced with <u>HicamsOnCall@ncdot.gov</u> - SQA 23093
- Changed the HiCAMS Database Error message to default to Email instead of Print. This way the error message can be sent by email when reporting it to HicamsOnCall. - SQA 23095

## **CONTRACT MAINTENANCE - Authorize Contracts**

 Added a new indicator for Steel Price Adjustments. Users requested the ability to designate a contract that is subject to Steel Price Adjustments. Then they needed to be able to mark which line items on their contract are subject to the adjustment. The adjustment itself is calculated outside of HiCAMS currently, we have provided reminder information to the RE office when they need to track/calculate those adjustments. - SQA 23085

## **CONTRACT MAINTENANCE - Review Contract Details**

## **CONTRACT MAINTENANCE - Review Subcontracts**

 2<sup>nd</sup> Tier Subcontract – Added the Committed and Committed Amount Indicators to the Subcontract window. This indicator will be editable for all Certification Types except NONE. When Committed Indicator is checked then Committed Amount column value is required (cannot be null or 0). – SQA 23029

## **CONTRACT MAINTENANCE - View Line Item Details**

 Added the Steel Price Adjustments indicator which shows whether the contract is designated (checked) or not designated (unchecked) for steel price adjustments -SQA 23085

#### **CONTRACT TRACKING – Review Pay Records**

 Pay Record window has been modified so that the void icon (pencil) menu item is not available for pay records which are entered through Sharepoint. - SQA 23059

#### **CONTRACT ESTIMATES - Review Estimates**

- Price adjustments refers to AC adjustments, Pay Factor adjustments and Fuel adjustments and do not display on the View Line Item Details window/module. Exception is the Emulsion for AST price adjustment which is an actual line item so this type of price adjustment does display on the View Line Item Details module. The Price adjustments are always calculated and included in the Overrun/Underrun Amount. - SQA 21985
- Added logic to give an informational message, if there are any Steel Price Adjustment line items in Non Processed Pay records status on a Contract that is Subject to Steel Price Adjustment. After generating the estimate application will give the informational message before completing the Estimate Generation. Example of the displayed message in pop-up ("A line item quantity subject to Steel Price Adjustment has been entered. Check for proper documentation and enter necessary Steel Price Adjustments.") - SQA 23089

## **CONTRACT ESTIMATES - Print CCU Estimates**

 Print CCU Estimates window has been modified to allow the estimate number to be entered for a Processed or Paid estimate of a contract (previously the estimate number was not changeable). The Contractor report is generated as a pdf file when hit Print icon menu item and save to the HiCAMS\hicamstemp directory folder by default. The directory folder of where to save the report can be changed. – SQA 23048

## FIELD INSPECTION REPORTS (FIR) - Review Field Inspection Reports

 Plastic Pipe Alt ID window has been modified to display the (vertical) scroll bar on the right side of the grid that lists the Alternate IDs for a material and add a row count on the Scan pop-up window. – SQA 23071

The notification is sent to selected staff and job titles when new aggregate material(s) have been added to the Materials tab found in the Vendor Producer/Supplier window for a Course Aggregate or Fine Aggregate plant. SQA 23055
- Added new notification *Plant ID X: Material(s) have been expired Alert.* This notification is set up in HiCAMS but is viewed in Vendor notifications window. The notification is sent to selected staff and job titles when one or more Aggregate material(s) are expired on the Materials tab found in the Vendor Producer/Supplier window for a Course Aggregate or Fine Aggregate plant. A nightly job is run after 12 am, to check for any materials that expired the previous day and sends an expired notification.– SQA 23066
- Added new notification Job Mix Formula: X Provisionally Approved/Approved Alert. This notification will be sent to selected staff and job titles when status on JMF is either Provisionally Approved or Approved. - SQA 23069
- Added new notification Job Mix Formula: X Provisionally Approved/Approved Alert. This notification will be sent to selected staff and job titles when status of JMF is Provisionally Approved or Approved. - SQA 23082
- Changed notification from Asphalt Mix Design: X Rejection Deleted to new description Asphalt Mix Design: X AMD Status: X was Deleted Alert. The application will notify the appropriate personnel each time an Asphalt Mix Design decision status Approve–No JMF, Not In Use or Rejection is deleted. - SQA 23098
- Changed notification description from Job Mix Formula: X Void was Deleted Alert, to Job Mix Formula: X JMF Status: X was Deleted Alert. The application will notify the appropriate personnel each time a Job Mix Formula decision status Provisionally Approved, Approved or Void is deleted. - SQA 23099

- <u>Samples</u> fixed Submitted Date on tool so it is pointing to correct table when data is displayed. - <u>SQA 23065</u>
- <u>Test Results (Samples)</u> added new dropdown to query tool to track the statuses of Asphalt and Aggregate sample results. – SQA 23102

The information includes the Map Number, Route Type, Route Number, GIS Route Number, Location, County, Treatment Type Number, Active, Date Created and Work Order. - SQA 23043
