- Regional designation and CUFC designation how to coordinate with MPOs?
- Differences between STC and Primary Freight System? Yes there are two separate systems.
- Potential criteria to add is the facility already designed to handle freight traffic?
- Supply chain analysis Comment: US-70 to Morehead city didn't score very well in this analysis.
- NCDOT: There were some concerns raised for the western part of the state. Specifically the fact that little to no industry showed up on the map when all industries (rather than key) were loaded. NC is the second most leader in production of Christmas trees and the feeling was that this is not being captured.
- NCDOT: With respect to the criteria, the feeling was that tonnage moved should be the lowest rank but that perhaps it should not be absolute tonnage but rather a percentage base on the total of the local economy.
