1. Analysis Maps

a. Overview

- i. Additional mapping was created with feedback from the committee and reflects what is already on the ground or a vision for the future.
- ii. These maps will be placed in the appendices of the CTP as further documentation.

b. Existing Bike Routes

- i. This map shows existing bike routes identified by NCDOT and Cape Fear RPO from feedback from NCDOT's Integrated Mobility Division, the NCDOT Pedestrian and Bicycle Infrastructure Network, the Cape Fear Regional Bicycle and Pedestrian Plan, and feedback from the committee
- ii. Attributes of crash locations will also be shown in the appendices and emailed out to the committee when the report is due for review
 1. A shapefile exists for attributes or attributes and can be requested from Nazia Sarder
- iii. Patrick Flanagan pointed out that there doesn't appear to be many crashes on the actual bike routes shown on the map. He mentioned that the bike routes could be old and may not get updated that often.
- iv. Dan Newquist asked about the range of dates for the crash history indicated on the map

c. Existing Bike Lanes and Sidewalks

- i. This map is in draft form and shows existing routes for sidewalks and designated bike lanes. Shapefiles and information on existing sidewalks are needed for further development of this map.

d. Public Transportation Origin and Destination Map

- i. Brunswick Transit System Community Connectivity Plan was used as base of map to show high on-demand transit origin and destination locations. Data is from May 2018. Map includes locations with over 20 pickup and drop-offs.
- ii. Helen Bunch asked if more current information could be attained before the document is published so that this map can show more up-to-date information.
 1. Yvonne Hatcher mentioned that any recent numbers would be similar to the numbers from May 2018.
- iii. Patrick Flanagan asked the group if the map makes sense in terms of where the origins and destinations are or if there is an area that is missing from the map.



1. Yvonne Hatcher recommended to add a footnote to map that mentions that the entire area is served in this map
- e. Downtown Sidewalks
 - i. Patrick Flanagan asked if the towns on the map make sense as far as defining a geography that would be considered a downtown or central business district so that an outline can be drawn around these areas.
 - ii. Dan Newquist asked about the type of feedback needed for this map and the bicycle route map
 1. The CTP Team is looking for additional potential destinations that would identify with what is already in the legend

3. Upcoming: Survey Results
 - a. A total of 6,969 surveys were completed (includes English, Spanish, and paper surveys).
 - i. Three paper surveys were received by NCDOT, and zero paper surveys were received by the county/municipality
