Brunswick County CTP Steering Committee Meeting

March 11, 2021

1. Base Year (BY) Roadway Network Final Map
 - a. Craig Eckert asked that the following roads be added because they are used to access schools in Brunswick County:
 - i. NC 133 (River Rd SE)
 - ii. Lake Park Dr SE
 - iii. SR 1319 (Union School Rd NW)
 - iv. SR 1114 (Zion Hill Rd SE)
 - v. SR 1330 (Waccamaw School Rd NW)
 - vi. SR 1119 (Stanley Rd SW)
 - vii. SR 1437 (Old Fayetteville Rd) – Outside of CTP study area
 - viii. NC 179 BUS (Village Rd)
 - ix. SR 1125 (Cedar Grove Rd)
 - b. Terry Pierce asked if low volume roadways can be included in the study as alternative routes. It was explained that these can be shown for bike and ped improvements. It was also added that when the CTP team completes a model run with FY projects and determines a roadway is over capacity the CTP team will then look at surrounding roads to study to relieve the capacity issues.
 - c. Patrick Flanagan requested that roadways suggested by the steering committee that were not included due to not meeting the selection criteria be documented for future reference during the study.
2. Future Year (FY) Roadway Network Review
 - a. Helen Bunch requested the Old Georgetown Rd be redesignated NC 179.
 - b. Terry Pierce requested to overlay all recommendations into one map. It was explained that this can cause a map to become crowded and difficult to read. If the steering committee would like to see something like this it can be put together but will only be for analysis purposes.
 - c. Abigail Lorenzo asked if NCDOT complete streets policy will be used in evaluating future projects. It was confirmed by the CTP team that all projects will be reviewed according to the NCDOT complete streets policy.
 - d. Craig Eckert informed the steering committee of the suggested project of signaling both sides of the interchange at NC 130 and US 17
 - e. Additional project suggestions included:

- i. Fifty Lakes Dr at NC 87, add turning lanes
- ii. Drayton Rd at NC 87, Pave roadway
- iii. Cougar Rd at NC 87, add crosswalks
- iv. Hickman Rd, addition of turning lanes
 1. A lot of development is planned for this area
 2. High traffic volume
- v. Carolina Bays Parkway extension to be show extending to the WMPO boundary
- vi. US 17 BUS in Shallotte
