1. Bicycle and Pedestrian Network Review
 - a. Projects currently included.
 - i. Projects from previous CTP
 - ii. Projects from Cape Fear RPO Bike and Ped Plan
 - iii. Current STIP Projects
 - iv. Reviewed the following local plans.

 - b. Terry Peirce asked about the inclusion of shared roadways in the CTP.
 - i. Bike shared routes not currently shown on the CTP maps because Bikes have same rights as auto traffic on roadways.
 - c. Nicole Morgan asked to include sidewalks on E Boiling Springs Rd as per the BSL Bike/Ped Plan.
 - i. CTP will be reviewing and including recommendations from the BSL Plan.
2. Possibility of Bike Share Routes Map
 - a. Terry Pierce added that 2 recent fatalities occurred because of heavy milling on the shoulders of roadways.
 - i. Would like to see repair of shoulders included in the plan.
 - b. Gene Smith supports the inclusion of Bike Share Routes Map in the Appendix
 - i. Also mentioned inclusion of Holden Beach Project on Ocean Blvd West
 - c. Caitlin Marks mentioned that Holden Beach is currently pursuing bike lanes along Ocean Blvd.
 - d. Terry Pierce pointed out the need for improved striping along roadways with increase of lane keeping technology on autos.

3. Future Year (FY) Roadway Network Final Map

- a. Numbers on the Recommendations List and FY Highway map are not listed in priority order, they are for reference only.
- b. Craig Eckert asked if Cougar Dr and NC 87 was included as a congestion project.
 - i. The CTP Team will take a closer look at Cougar Dr.
- c. Terry Pierce asked about the location of the I-140 Connector.
- d. Helen Bunch asked about a shoulder widening of SR 1303 Hickman Rd
 - i. This recommendation will be included in the Recommendation Sheet.

4. Survey Open Period

- a. Helen Bunch asked what locations survey responses are coming from.
 - i. The CTP Team will develop a map to share that includes locations of survey responses.
- b. Only 2 Spanish survey responses.
- c. Only 3 paper surveys received.
- d. Dan Newquist asked if any themes have presented themselves up to this point.
 - i. No common themes have been seen at this point in the survey.
