WHEREAS, Carteret County, the municipalities within Carteret County, the NCDOT Transportation Planning Branch and the Down East RPO actively worked to develop a transportation plan for Carteret County and the municipalities; and

NOW THEREFORE, BE IT RESOLVED: That the Carteret County Comprehensive Transportation Plan as shown on the attached maps dated May 30, 2012 be approved and adopted as a guide in the development of the highway, transit, bicycle, and pedestrian systems and the same is hereby recommended to the North Carolina Department of Transportation for its subsequent adoption:

## RESOLUTION ADOPTING THE CARTERET COUNTY COMPREHENSIVE TRANSPORTATION PLAN FOR THE TOWN OF CAPE CARTERET, NORTH CAROLINA ATTACHMENT A June 18, 2012

The following items are highway project proposals specifically affecting the Town of Cape Carteret:

- 1. Project ID CART00012-H Relieve congestion on NC 24 from US 70 Intersection to Cedar Lane using Access management and traffic signals. The Town does not want medians installed within the jurisdiction of Cape Carteret.
- 2. Project ID CART00013-H Relieve congestion on NC 24 at the intersection of NC 58 by converting the at-grade intersection to an interchange.
- 3. Project CART00032-H Improve connectivity on Taylor Notion Rd. from NC 24 to NC 58 by widening of lanes and shoulders and an intersection realignment at the intersection of Taylor Notion Rd. and NC 58.
