

Identified Need

NC 59 (Hope Mills Rd) in Hope Mills is projected to be over capacity by year 2045. Improvements are needed to relieve congestion on the existing facility and accommodate projected traffic volumes such that a minimum of Level of Service (LOS) D can be achieved.

Recommendation

The proposal is to convert existing 4-lane undivided roadway w/TWLTL to 4-lane median divided roadway w/raised concrete median, curb & gutter and sidewalks.



Project History/Linkage to Other Plans

There is STIP project EB-6032 along NC 59 (Hope Mills Rd). EB-6032 project is to construct a sidewalk from Fayetteville City limits to Sumac Circle. NC 59 is currently a 4 lane facility with continuous center left turn lane. Additionally, this segment of NC 59 has a speed limit of 45 mph.

Project EB-6032 is fully funded along NC 59 (Hope Mills Rd) in the 2020-2029 STIP. The STIP project is currently under construction and Right-Of-Way is in progress.

NC 59 (Hope Mills Rd) is projected to be over capacity by year 2045.

The purpose of this project is to reduce congestion, reduce travel time, and improve safety along this facility. FAMPO003-H received 1 comment regarding the need for transit during the survey period. The Survey was launched on August 12, 2020 and closed on September 28, 2020. There was an English and Spanish version of the survey. A total of 228 participants created 530 comments / suggestions on the map of Cumberland County / FAMPO.

Potential Impacts

It would further improve upon the proposed project FAMPO004-H and strengthen the regional connection between Fayetteville and Hope Mills.


