Purpose: Facility Deficiencies

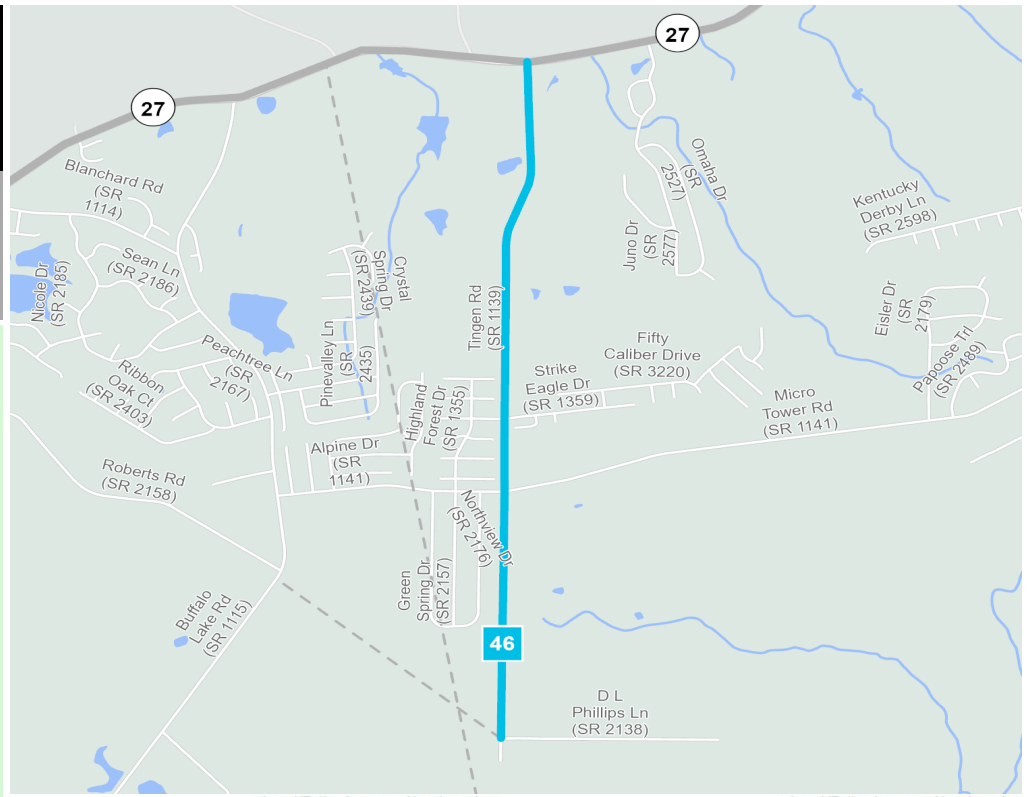
Improvement: Widening

Identified Need

This route is not up to current standards and is lacking adequate shoulder and lane width.

Recommendation

This Project, was first identified in the 2011 Harnett County CTP, as a minor widening improvement. This road does not meet the modern standards. It is recommended to be upgraded to 12 foot lanes with paved shoulders to improve mobility and connectivity.

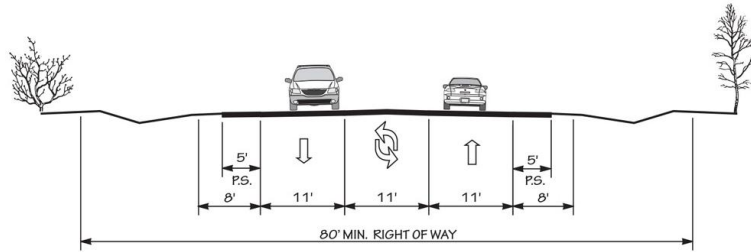

This project, HARN0032-H, was first identified in the 2011 Harnet County CTP. The CTP project proposal (Local ID HARN0032-H) was listed under minor widening improvements. Minor Widening improvement routes do not have capacity issues, but are recommended to be upgraded to two 12-foot lanes with 2-foot paved shoulders to improve safety or to correspond to proposed bicycle improvements.
