Identified Need


Rockfish Road (SR 1406) is projected to be near capacity by 2045. Improvements are needed to accommodate projected traffic volumes such that a minimum LOS D can be achieved.

Recommendation

Project U-5857/ U-5707 proposes to widen Rockfish Road (SR 1406) and extend Gillis Hill Road (SR 1420) approximately 1.5 miles on new location. The proposed typical section consists of a four-lane divided section with a raised grass median and shoulder section.



Project History/Linkage to Other Plans

U-5857 and U-5707 are being developed in coordination with STIP U-5798, the Widening of SR 1102/SR 1420 (Gillis Hill Road) and U-5753, the Widening of SR 1305 (Wayside Road) and SR 1418 (Lindsay Road).

The proposed projects are included in the approved 2020-2029 North Carolina State Transportation Improvement Program (STIP) with right-of-way acquisition for both projects scheduled for Fiscal Year (FY) 2027 and construction scheduled for FY 2029.

CTP Goal Analysis

SR 1406 (Rockfish Road) is a primary local travel corridor connecting southeastern Hoke County with the community of Rockfish and the City of Raeford. The population in Hoke County is projected to increase at a rate of 2.5% annually, which is more than double the statewide projection for population growth. Traffic is expected to increase along with the population growth, and the number of commuters traveling from surrounding communities through Rockfish to Fort Liberty and the City of Fayetteville is also expected to increase. Comment recommending traffic signal improvement and a bicycle map marker were received during the survey period for U-5857/ U-5707 project. The Survey was launched on August 12, 2020 and closed on September 28, 2020. There was an English and Spanish version of the survey. A total of 228 participants created 530 comments / suggestions on the map of Cumberland County / FAMPO.
