Identified Need

Morganton Rd near the Cross Creek Mall is projected to be over capacity by year 2045. Improvements are needed to relieve congestion on the existing facility and accommodate projected traffic volumes such that a minimum of Level of Service (LOS) D can be achieved.

Recommendation

Upgrade multi-lane facility, add raised median and remove the center left turn lane. Include Intersection improvement to alleviate the congestion.

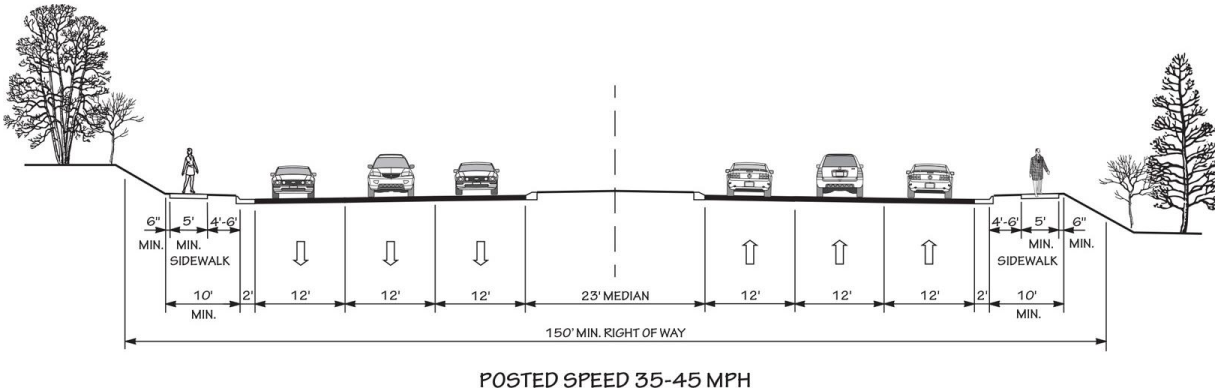

This network deficiency has been identified in the FAMPO / Cumberland County CTP, and it is recommended to have an intersection improved to address the deficiencies.

Goals & Objectives Survey

FAMPO009-I received one bicycle map marker during the survey period. The Survey was launched on August 12, 2020 and closed on September 28, 2020. There was an English and Spanish version of the survey. A total of 228 participants created 530 comments / suggestions on the map of Cumberland County / FAMPO.

FAMPO009-I occurs within a Natural Heritage Element Occurrences zone and crosses Buckhead Creek.
