Amendment #1

The Durham-Chapel Hill-Carrboro Metropolitan Planning Organization (DCHC MPO) proposes that the DCHC MPO and NCDOT amend the Comprehensive Transportation Plan (CTP) to change the proposed future configuration of the segment of Farrington Road between Southwest Durham Drive and the Falconbridge Road Extension. The CTP currently lists this roadway segment as a future four-lane divided cross-section. The MPO believes that a twolane cross-section that includes bicycle and pedestrian facilities is more appropriate for forecasted traffic volume in that corridor and the future, adjacent land use. The segment of Southwest Durham Drive that is north of the Southwest Durham Drive/Farrington Road convergence (i.e., close to where the converged roadway crosses I-40) is defined as a future four-lane divided facility. This converged roadway will be capable of handling the combined vehicles to/from the 2 two-lane roadways to the south, i.e., Farrington Road and Southwest Durham Drive.

The table below shows the current and proposed amendment #1 attributes for this segment of Farrington Road in the CTP. The proposed changes are shown in **bold blue** font – the cross section will be 2E (2-lane with bicycle and pedestrian facilities) and the classification will be minor arterial.



Schedule and Public Involvement


The MPO's public involvement policy requires that this proposed amendment be released for public input for a minimum of 42 days. The schedule for amendment #1 will be:
