Montgomery County CTP Summary of Amendments (Adopted by NC Board of Transportation on May 2, 2019)

In March 2018, the Piedmont Triad Rural Planning Organization (PTRPO) requested from the Transportation Planning Division of the North Carolina Department of Transportation (NCDOT) to amend the 2012 Montgomery County Comprehensive Transportation Plan (CTP). The mode of transportation evaluated as part of this amendment only included the highway network. Refer to the original 2012 Montgomery County CTP adopted on March 8, 2012 by NCDOT for all other related information. This plan does not cover routine maintenance or minor operations issues.

HIGHWAY

Town of Biscoe

- NC 24/27: Revise the CTP designation of NC 24-27 from the Moore County line to I-73/74 from "Expressway Needs Improvement" to "Boulevard Needs Improvement". Amendment requested by the PTRPO to be consistent with possible roadway design improvements identified in the Moore County CTP, to maintain and improve access, to improve mobility and safety, and to add operational improvements to key intersections on NC 24/27.
- NC 24/27: Revise the CTP designation of NC 24-27 from I-73/74 to Coggins Road (SR 1336) from "Expressway - Needs Improvement" to "Other Major Thoroughfares – Needs Improvement". Amendment requested by the PTRPO to maintain and improve access, to improve mobility and safety, and to add operational improvements to key intersections on NC 24/27.

Town of Candor

- US 220 ALT (N Main Street): Revise the CTP designation of US 220 ALT from W Ewing Street (end of median) to S Whiskey Road (near Town Hall) from "Other Major Thoroughfares Existing" to "Other Major Thoroughfares Needs Improvement". Amendment requested by the PTRPO to improve mobility, safety, and access, while also adding operational improvements to key intersections along US 220 ALT.
- NC 211: Revise the CTP designation of NC 211 from the Moore County line to I-73/74 from "Expressway Needs Improvement" to "Boulevard Needs Improvement". Amendment requested by the PTRPO to be consistent with possible roadway design improvements identified in the Moore County CTP, to maintain and improve access, to improve mobility and safety, and to add operational improvements to key intersections on NC 211.

Town of Mt. Gilead

- NC 73: Revise the CTP designation of NC 73 through the town core from "Other Major Thoroughfares - Existing" to "Other Major Thoroughfares - Needs Improvement". Amendment requested by the Town of Mt. Gilead to allow for future roadway design changes improving the safety, mobility, and access, and to add operational improvements to key intersections on NC 73.
- NC 109: Revise the CTP designation of NC 109 from NC 731 to Hearne Farm Road (SR 1127) from "Other Major Thoroughfares Existing" to "Other Major Thoroughfares Needs Improvement". Amendment requested by the Town of Mt. Gilead to improve mobility, safety and access, and to add operational improvements to key intersections on NC 109.
- NC 731: Revise the CTP designation of NC 731 from Park Avenue to NC 109 from "Other Major Thoroughfares - Existing" to "Other Major Thoroughfares - Needs Improvement". Amendment requested by the Town of Mt. Gilead to improve mobility, safety and access, and to add operational improvements to key intersections on NC 731.

Town of Troy

 NC 24/27: Revise the CTP designation of NC 24/27 from Page Street (SR 1332) to Dogwood Avenue from "Other Major Thoroughfares - Existing" to "Other Major Thoroughfares - Needs Improvement". Amendment requested by the PTRPO to improve mobility, safety, and access, and to add operational improvements to key intersections along NC 24/27.
