Traffic Forecast for B-5321 SUBJECT:

Wake County

Replace Bridge No. 374 on SR 1153 (Old Holly Springs Apex

Road) over Little Branch.

Please find attached the 2019/2045 traffic forecast for B-5321 in Wake County.

The forecast represents project No-Build and Build conditions. Replacing Bridge No. 374 is not expected to substantially affect travel demand along SR 1153.

Certain Assumptions were made during the development of this forecast.

Fiscal Constraint:

Within an MPO area travel demand forecasts assume the construction of projects listed within an MPO's Metropolitan Transportation Plan (MTP). This forecast is consistent with the 2045 MTP of the Capital Area Metropolitan Planning Area (CAMPO) adopted in February of 2018.

Projects listed in the MTP which are expected to affect travel demand along SR 1153 at Bridge No. 374 include:

- SR 1153 4-lanes from Holly Springs Apex Road to Jessie Drive (including bridge 374).
- Avent Ferry Connector from SR 1153 to Holly Springs Road.
- Interchange at NC 540 and Old Holly Springs Apex Road.

Development Activity:

633 homes are currently under construction in the 12 Oaks development along SR 1154 (Woods Creek Road) and near its intersection with Old Holly Springs Apex Road. Traffic generated by this development is accounted for in the 2045 traffic forecast.

Forecast Methodology:

The 2019 estimate is based upon current traffic counts. The 2045 forecast is based upon travel demand predictions of the Triangle Regional Model (v6).

The use of straight-line interpolation to estimate AADT for years between 2019 and 2045 is acceptable.
