Development (BUILD) grant in order to secure additional funding for STIP Project A-0009C. This project proposes improvements to Corridor K along US 129, NC 143, and NC 28 from Robbinsville to Stecoah in Graham County in order to improve mobility and reliability of the transportation infrastructure. Quality of Life: Support for improved connectivity to jobs, health care, etc., broadband installation,

increased transportation choices

Innovation: Innovative technologies, project delivery, or financing Partnership: Collaboration among a broad range of stakeholders
