The Rowan County Board of Commissioners strongly supports the Town of East Spencer's application to the U.S. Department of Transportation for a BUILD grant opportunity to support the construction conversion of Correll Street/McCanless Road from an underpass to an interchange on I-85 in Rowan County.

East Spencer is one of the valued communities that makes up Rowan County. In the past, East Spencer has suffered from persistent poverty, lack of residential and industrial growth, and transportation issues. For decades they have had significant economic challenges.

But today, for the first time in a generation, East Spencer is receiving much-welcomed interest from the industrial and residential development community. However, much of the area that is receiving interest is along the I-85 corridor and is not yet developable because of transportation access issues.

The East Spencer Interchange for a Growth Nexus (DESIGN) project provides a historical opportunity to finally address the long-term transportation and economic challenges facing the Town, a town that is both a Historically Disadvantaged Community (HDC) and an Area of Persistent Poverty (AoPP). We fully believe that this project is key to addressing East Spencer's long-term transportation and economic barriers. The town, which is historically and predominantly African American, was largely cut off from nearby communities to the west by the railroad, to the east by Town Creek, and without any direct connections to the south. The Town has relied on Long Street to access adjacent communities, but we believe that direct access to Interstate 85 immediately changes East Spencer's future, providing access, opportunity, and hope to the community,

The DESIGN project will enable East Spencer to address many of its long-term challenges. Town residents and heavy commercial traffic will benefit from a more direct access to I-85. This access will decrease traffic on Long Street, helping address environmental issues created by significant traffic sitting idle at multiple stop lights along Long Street. This grant represents an historic opportunity to transform East Spencer, breaking the cycle of disinvestment and opening pathways to economic prosperity for its residents.

I write to offer my support and endorsement for the Town of East Spencer's application to the U.S. Department of Transportation for a Better Utilizing Investments to Leverage Development (BUILD) grant. Our neighbors are pursuing the grant to support the construction conversion of Correll Street/McCanless Road from an underpass to an interchange on I-85 in Rowan County.

Interstate I-85 from Raleigh to Charlotte has, for decades, been touted as the fertile crescent of economic development for central North Carolina. Until recently, however, most development activity has been focused in the Charlotte, Triad, and Triangle metro areas. As property costs and population densities have risen in those areas, new development opportunities are finally reaching counties like Rowan, including small communities like Spencer and East Spencer.

Rowan County has many assets to leverage, such as reasonably priced land supported by natural gas lines, rail access, electrical generation and water/wastewater treatment capacity, and an underutilized labor force. To maximize the opportunity for our community to contribute to industrial development, some infrastructure needs must be met. Collectively, these projects are known locally as the Northern Rowan Connector, to promote regional connectivity, enhance quality of life, and bolster the economies of Rowan County's northern gateway communities. The new I-85 exit is one of these key projects.

While the Town of East Spencer runs adjacent to I-85 for over four miles, access is currently limited to only one interstate interchange and few parallel access roads. To adequately serve existing industrial clients, residential developments, and to open new land for economic development, East Spencer needs an additional interchange.

This is one of several needed road and infrastructure improvements in our area. Combined with an exciting a former textile mill redevelopment and a bold vision for enhancing our pedestrian connectivity and outdoor recreation economy, we have many additional projects that will complement a new interchange serving East Spencer and beyond. The success of all these projects would create a big impact in housing opportunity, job creation, and growth in our local tax base.

While our neighbors in East Spencer are leading this project, we wholeheartedly support this effort that will lead to increased economic opportunity for everyone in our area. Additional employment, housing, commerce, and recreation options will be a direct result of a new interstate interchange and are significant needs for northern Rowan County.
